Institutional Effectiveness Weekly Report

April 21, 2017

The Office of Planning and Assessment reports its weekly activities and contributions toward Texas Tech University's institutional effectiveness efforts and departmental objectives.

OUTCOME 1: Texas Tech will be found in compliance with all external accrediting agencies and State of Texas mandates

- ✦ Substantive change documentation describing the office's internal documentation process has been updated to reflect ongoing improvements. Additionally, all substantive change documentation is up-to-date.
- ✦ Using the Student Learning Outcomes Mapping document, OPA has begun mapping programs' SLOs to Marketable skills criteria. The identified criteria are:
 - Critical Thinking
 - Communication
 - Quantitative Skills
 - Teamwork
 - Social Responsibility
 - Personal Responsibility
 - Employment-Oriented
 - Application to Discipline
 - Professional Skills
 - Contribution Toward Future Education
- ✦ As we prepare for the Fifth Year Interim Report, the Office of Planning and Assessment is reviewing the existing student support level definition. As a part of the definition revision, OPA is preparing recommendations to expand the existing list of departments.
- ✦ The Program Assessment Rubric (PAR) has been adapted for faculty peer review processes. The simplified peer review is a variation of the PAR that encourages faculty reviewers to review the assessment report from a disciplinary perspective. The face validity review that OPA provides, in collaboration with the disciplinary review that the peer review process provides, has the potential to add significant value to the process. There are two versions of the simplified peer review. The first version is a Word document that can be shared with College Level IE Committees. However, there is also a Qualtrics version available that could assist OPA with reviewing results with more detail. A snapshot of the Word document is below.

1-5-17	Angela Lumpkin	Kinesiology and Sport Management	Lumpkin revised KSM faculty roster during meeting. Betty Ann has already made modifications to DM. Dr. Lumpkin shared that many of the KSM degree programs have completely revised their assessment plans.
1-6-17	Magda Toda	Mathematics and Statistics	Toda was pleased with department's PAR scores. This department has significantly improved its assessment processes, thanks to the efforts of Professors Toda, Brock, and Harris.
1-6-17	Sean	History	Hughes presented PAR review, and information

	Cunningham		regarding CAAP testing. History may be a good CAAP partner. No concerns expressed by Dr. Cunningham.
1-13-17	Saif Haq	Architecture	Hughes presented PAR review, discussion ensued about NAAB accreditation and how the College has focused its TracDat reporting based on NAAB standards. Haq was also presented information on CAAP testing. The College may also be a good candidate for CAAP testing. Haq also requested a DM document to remind faculty on how to upload their syllabi. Hughes sent this document.

Simon was pleased with department's PAR review. Simon indicated that since the department's assessment efforts have been successful, the annual assessment meeting is unnecessary.

2-10-17	Susan Tomlinson	Honors College	Hughes presented PAR findings to Tomlinson. Tomlinson and Brink collaborate on assessment reporting. No follow-up action required for Honors.
2-15-17	Phil Johnson	Agricultural Economics	Hughes presented PAR findings to Johnson. Johnson has re-designed all assessments in Ag Eco. All assessment reporting is conducted by Johnson. No follow-up actions needed. Johnson completed faculty roster during appointment.
2-22-17	Dennis Patterson	Political Science	Hughes presented PAR findings. Patterson and Mitchell collaborate on assessment reporting. Patterson did not complete faculty roster during appointment.

4-12-17	Scott Burris	Agricultural Communication and Education	Hughes shared PAR findings with Burris. Burris is currently serving as Interim Chair. This was Burris' first assessment meeting. Hughes shared that October 1 deadline is "back to normal."

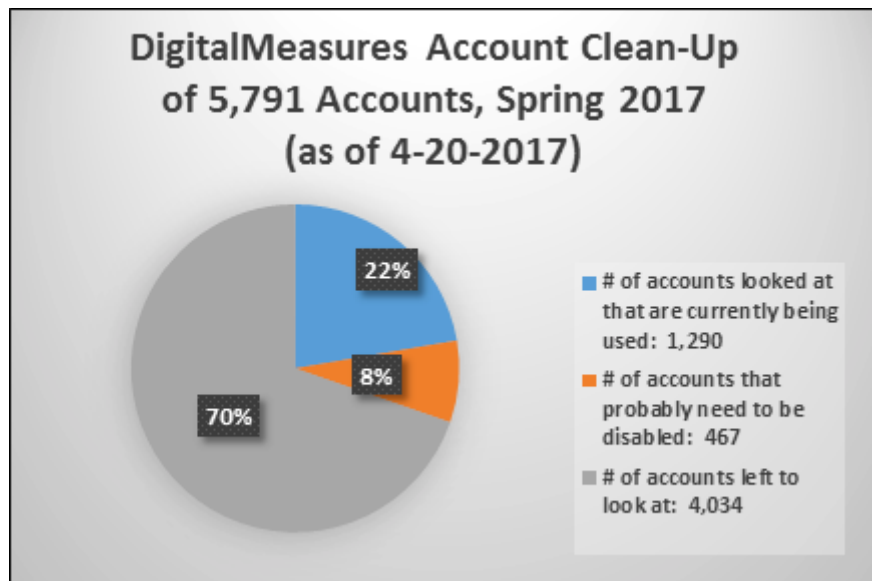
✦ Faculty Credentialing Activity

- Betty Ann Thomas completed DigitalMeasures' Activity Insight certification this week. This demonstrates a robust understanding about the management of the software. Certification is recommended by the company for each institution.
- DigitalMeasures rolled out a new stock report that illustrates completeness of data in faculty accounts that are utilized in DM's usage statistics reports. OPA is deciding how to best use this report, possibly sharing it with Chairs or with individual faculty.
- DigitalMeasures announced a new data integration partnership with Scopus, the largest abstract and citation database of peer-reviewed literature, including scientific journals, books, and conference proceedings. TTU has a Scopus license; OPA will coordinate with library personnel as this integration occurs. It will be available to faculty in June of 2017.

OUTCOME 2: The Office of Planning and Assessment will contribute to the Office of the Provost’s institutional planning processes

- ✦ The Online Senior Assessment (OSA) currently has 257 responses. Last spring’s OSA administration ended with 553 responses. Two more reminders will be sent to students before the OSA closes on May 1.
- ✦ OPA staff have continued to analyze the Raiders Engaged survey data while simultaneously preparing for the OPA Learning Series presentation on the fall 2016 data. OPA is planning on a redesign of the summary report to incorporate a web-based format which will be printable to a PDF if needed. Also, Dr. Birgit Green, Application and Development, and OPA are preparing for the 2016-2017 Administration of the Raiders Engaged survey with enhancements and improvements in functionality.

OUTCOME 3: The Office of Planning and Assessment will continually monitor the university’s compliance with laws, policy statements, and policies deriving from the State of Texas, THECB, and SACSCOC

✦ THECB

- A topic of much interest recently on the THECB website is “predictive analytics” (PA). PA refers to statistical analysis that extracts large amounts of historical data using various technologies to uncover relationships and patterns that can be used to predict behavior and events. A recent survey of Texas institutions of higher education demonstrated that 62% are currently using PA and 30% are interested in using it. Colleges in the United States are using PA to:

- Identify at-risk academic and non-academic behavior and plan interventions
- Match students with courses and majors and make recommendations of sequence of courses
- Accelerate and enhance learning by anticipating content and resources to meet learner’s needs
- Use past data to predict type of students who will enroll
- Assist with marketing and recruitment

✦ A major policy discussion on PA is set for April 20 at the THECB meeting. PA has been identified as a strategy in the 60x30TX strategic plan for higher education and has the potential to make an impact across the state on student persistence and completion.

✦ A table was posted of changes in average budgeted faculty salaries from 2015 to 2016. Information is presented here of Texas Tech as compared with peer institutions [as suggested in TTU’s 2010-2020 Strategic Plan], along with the state weighted average.

- ✦ OPA is working closely with the College of Education during its assessment leadership transition within the COE. OPA is assisting the COE with streamlining internal assessment processes to align with institutional assessment reporting expectations. This week, OPA met with the COE IT group to review their internal reporting software to discuss how the software could assist with institutional reporting.
- ✦ OPA is working closely with Industrial Engineering to input data from their most recent ABET Report into TracDat in the Actions for Improvement section.
- ✦ The Assessment Innovation Grant has been available on the OPA website at <https://www.depts.ttu.edu/opa/innovationgrant.php>. There has been one submission already.
- ✦ The OPA Annual Report is now available online as well at <https://www.depts.ttu.edu/opa/docs/OPAAnnualReport2017.pdf>
- ✦ Finally, the Portfolio Resource page is still in development, but available to view at <https://www.depts.ttu.edu/opa/portfolio/>. The page will become active once needed information and new graphic is available.
- ✦ On Wednesday, April 19, OPA staff hosted the Spring 2017 OPA Learning Series Event titled *Implications of Revised SACSCOC Principles*. In addition to OPA staff, a small group of 4 staff members and 2 faculty members attended. Several faculty members emailed OPA about the inability to attend due to teaching schedules, so the presentations were emailed to these faculty.
- ✦ OPA routinely surveys individuals that we have worked with through Chair Visits, Program Coordinator Consultations, and SSL Feedback Meetings. Below are the results of the survey to date for 2016-2017.

In addition to direct contributions toward the departmental goals, OPA continues to focus on continuous improvement measures.

- ✦ OPA staff have been managing a registration survey in Qualtrics for the Study Abroad office’s Pre-Departure Orientation for students who are planning to study abroad. This survey was able to successfully track student registration over a 2.5 week period and 11 registration dates. This is the first survey OPA has administered through Qualtrics and it was able to showcase much of the functionality of the survey platform. Today is the final day of the PDO survey.
