Preparation for SACSCOC Fifth Year Interim Report

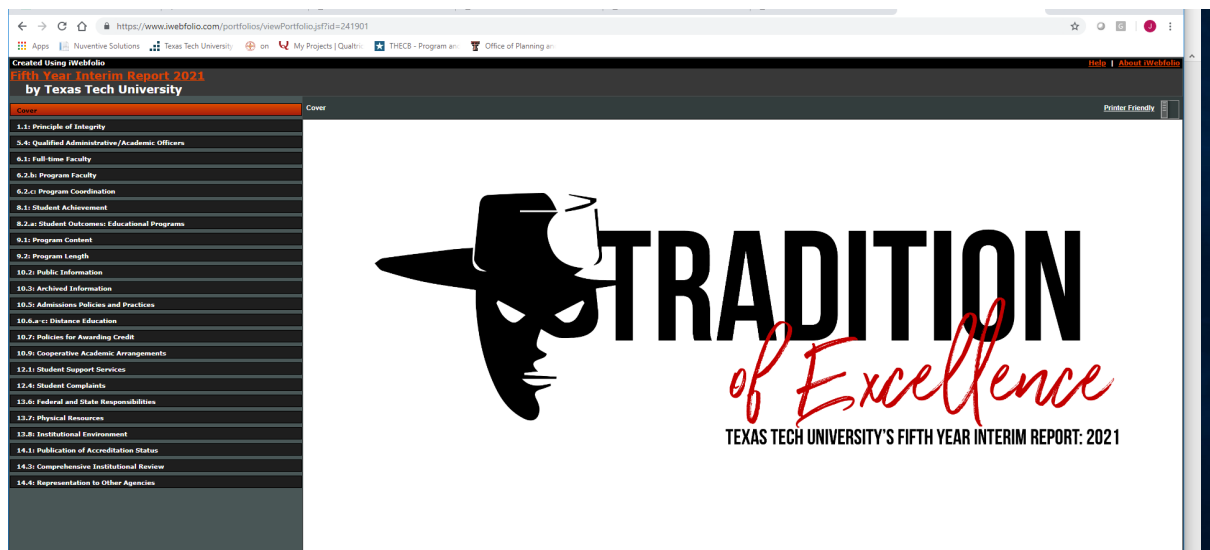
The Office of Planning and Assessment reports its weekly activities and contributions toward Texas Tech University's institutional effectiveness efforts and departmental objectives.
