



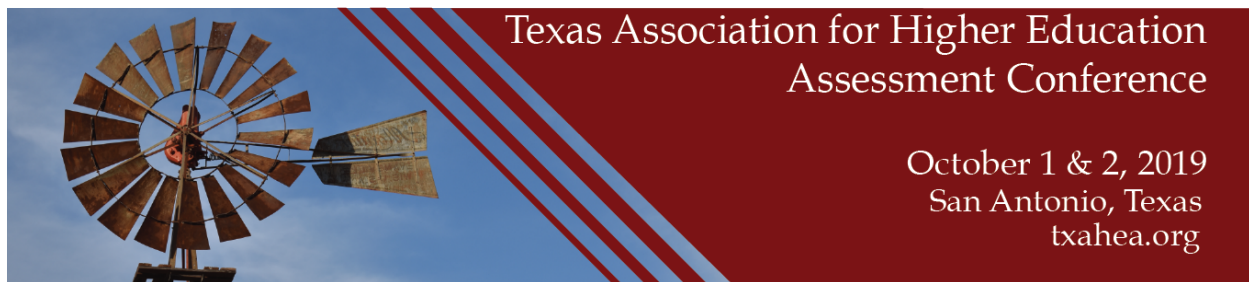

Institutional Effectiveness Weekly Report

May 3, 2019

The Office of Planning and Assessment reports its weekly activities and contributions toward Texas Tech University's institutional effectiveness efforts and departmental objectives.



OUTCOME 1: The Office of Planning and Assessment will contribute to Texas Tech University's ongoing compliance with all external accrediting agencies and State of Texas mandates.

- ✦ Fifth Year Meeting
 - On April 29, Dr. Darryl James conducted a Fifth-Year Interim Team Leader meeting. Multiple resources were distributed. OPA will organize team meetings during the summer 2019 term.
- ✦ The University-Level Institutional Effectiveness Committee held its spring meeting on April 30. Dr. David Roach recommended that OPA should meet with college deans to ensure they are informed about gaps in assessment reporting. The primary agenda items were:

✦ Substantive Change

- Over the past few months, OPA staff have been diligently reviewing the spreadsheet used to track local substantive changes. OPA staff have vetted the 2015-2016 and 2016-2017 substantive change spreadsheets and will continue with the same process for the 2017-2018 spreadsheet. During this time, OPA staff have also been keeping up-to-date with the current 2018-2019 substantive change requests. OPA is confident that this report will be beneficial to the SACSCOC Fifth-Year Interim Report.
- ✦ The first draft of the 2017-2018 Program Assessment Rubric (PAR) Summary Report has been completed and submitted to the University-Level Institutional Effectiveness Committee for review. The report will not be completed until Faculty Peer Reviews are finalized.
- ✦ An email message was sent to the Assessment Liaison eCommittee on May 1. Topics addressed in the spring email were:
 - PAR Evaluations for 18-19
 - October 1 deadline for reporting
 - Methods of Assessment Analysis

- Changes to OPA contacts during summer
- ✦ Texas Higher Education Coordinating Board and State of Texas Reporting
 - Course-level surveys were submitted beginning April 29 to Instructors of Record. Direct emails were sent for the first time this semester and the process seems to be going very well. Data will be extracted and analyzed this summer.
 - TechQuest will be administered next fall. Core Curriculum committee members have been contacted to ask for updates to the instrument.
 - OPA is preparing to close the ETS Proficiency Profile to Texas Tech senior students. Scholarship winners will be announced on May 7, 2019.
 - OPA continues to update its website content and is currently updating the Marketable Skills Major Exploration page.
- ✦ Quality Enhancement Plan
 - Dr. Paul Pare has been working with OPA to develop a pre-departure survey for study abroad students to measure student preparedness. Dr. Pare has worked extensively with Dr. Aliza Wong and the Study Abroad Office on the instrument. The survey was administered on April 30, and will remain open.

OUTCOME 2: Texas Tech University faculty and staff will be well-prepared to meet OPA’s faculty credentialing, assessment, and strategic plan expectations.

- ✦ Training and Consultation Tracking
 - These totals include consultations and communications where the OPA provides support for faculty and staff on non-project specific activity.

- ✦ OPA staff are planning a summer 2019 meeting with College of Engineering department chairs. The purpose of this meeting is to distribute an ABET assessment template for all chairs. Additionally, OPA will share the enhancements we have customized specifically for Engineering chairs.

- ✦ All Actions for Improvement reports have been distributed to department chairs.
- ✦ Developmental Opportunities
 - Coffee Breaks
 - The May Coffee Break event titled “How Texas Tech University is Leading the Way with Innovation” was presented by Kimberly Gramm on May 2. Attendance was lower than previous Coffee Break sessions, likely due to the time of year. The presentation, however, went well.



- OPA is updating the planning calendar for summer and fall trainings. Fall trainings will not be scheduled until later this summer when the TLPDC opens their scheduling access. Summer training opportunities have been finalized.
- ✦ Institutional Assessment
 - The Raider’s Engaged final report is being finalized, including data from previous years to allow trending patterns and areas of improvement to be more evident. OPA is hoping to have a final version of this report in early May. The O&E Taskforce continues to meet regularly, and updates will be reflected in new instrumentation and assessment methodologies.

 - The Office of Planning and Assessment continues to collaborate with Dr. Allie Smith in the Honors College. OPA staff created and distributed a second pi2 Program Assessment Survey.
