
Chair Meeting Update

This week, OPA staff met with department chairs from Journalism & Creative Media Industries, Public Relations, Marketing & Supply Chain Management, ISQS, and Professional Communication. All departments received their annual PAR report, and they also received a new report that provides information specific to faculty credentials within their area. Department chairs/area coordinators were asked to rectify these issues with individual faculty members. For example, some faculty members did not have their full academic credentials entered, and so we highlighted faculty who need to bolster their individual records. Next week, we will meet with the following departments: Advertising & Brand Strategy, and Energy Commerce & Business Economics. Kahlie Callison is currently scheduling meetings for the College of Education, Whitacre College of Engineering, and College of Architecture.

Summer HB 2504 Update

After final reports regarding House Bill 2504, we have reduced the number of Summer I missing syllabito just 12 total, out of almost 2800 courses, representing 99.6% compliance. While we are still working with departments and colleges to secure the remaining syllabi, our focus is now shifting towards transcript compliance. An email will go out to faculty, chairs, and deans later this Summer with reports of those who need to update their DM accounts, those who need supplemental information, and those who may need to provide a justification statement or cert form.

Chart 2. Student Learning Outcome Analysis within the BSARCH Degree Program





Chart 3. Student Learning Outcome Analysis within the MARCH Degree Program
