

LAW Important Dates – Summer 2014

SUMMER I

April 18, Friday

- Fee Assessment Occurs for Summer 2014 (Charges Available for viewing if Registered for Classes)

April 26, Saturday

- Summer I Payment Plan available for enrollment

May 6, Tuesday through June 10, Tuesday

- Carry-forward loans available for qualifying students.

May 15, Thursday through June 18, Wednesday

- Book loans available – must be re-paid by June 25, Wednesday

May 16, Friday

- Financial Aid Disbursed for Summer I
- Financial Aid refunds begin

May 19, Monday

- LAW - payment deadline. Registration changes made after this date could affect the student's account balance, and must be paid immediately unless the student is enrolled in a Summer I Payment Plan

- Book loans available – must be re-paid by July 25, Friday

June 20, Friday

- Financial Aid Disbursed for Summer II
- Financial Aid refunds begin

June 24, Tuesday

- LAW - payment deadline. Registration changes made after this date could affect the student's account balance, and must be paid immediately unless the student is enrolled in a Summer II Payment Plan

June 27, Friday

Withdrawal dates for LAW Summer I 2014:

May 20 or earlier -100% refund
May 21 through May 23 - 80% refund
May 24 through May 29 - 50% refund
May 30 through end of session- No refund

Withdrawal dates for LAW Summer II 2014:

June 29 or earlier -100% refund
June 30 through July 2 - 80% refund
July 3 through July 8 - 50% refund
July 9 through end of session- No refund

Withdrawal dates for LAW Full Summer 2014:

May 20 or earlier -100% refund
May 21 through May 28 - 80% refund
May 29 through June 4 - 70% refund
June 5 through June 11 – 50% refund
June 12 through June 18 – 25% refund
June 19 through end of session- No refund
