Movement of cottonseed to oil mills in western states continued to decline during the week ended January 26, according to the Cotton Division, Agricultural Marketing Service, USDA. Inclement weather kept final harvesting to a minimum and slowed moduled seed cotton delivery to gins. Few gins had backlogs other than module stored seed cotton. Demand for cottonseed products remained fairly good. Cottonseed grade certificates received from licensed chemists totaled 386 this week. This compares with 316 certificates received a week earlier and 921 during the corresponding period last season.

Cottonseed receipts at oil mills totaled 526,000 tons during December, according to the Bureau of the Census. This was the smallest December receipts since 1967 and was down from 1,231,000 tons a year earlier and 646,000 two years ago. Through December this season, oil mills had received 3,024,000 tons compared with 4,291,000 a year ago and 2,674,000 tons prough December 1980. Oil mills crushed 423,000 tons of cottonseed during December, bringg crushings for the season to 1,872,000 tons. This was the largest crushings for the August-December period since 1966 and was up from 1,686,000 tons a year earlier and 1,828,000 tons two years ago. End-of-December stocks of cottonseed at oil mills totaled 1,933,000 tons against 3,002,000 tons a year earlier and 1,904,000 tons two years ago.

Cottonseed receipts at oil mills in western states continued to decline during the week ended January 19, according to the Cotton Division, Agricultural Marketing Service, USDA. Harvesting lingered in final stages. Cottonseed grade certificates declined to 316 compared with 378 a week earlier.

World cottonseed production for 1982-83 is forecast at 26.8 million tons, a 4 percent drop from last year's record world harvest of almost 28.0 million tons, according to the Foreign Agricultural Service, USDA. The increase in China's production of over 800,000 tons and in Pakistan of 70,000 tons was more than offset by the decline of over 1.4 million tons in the United States, as well as significant decreases in Mexico and Egypt.

As a by-product of cotton ginning, cottonseed production is not directly determined by domestic and international supply and demand factors that affect other oilseed output. Cottonseed is rather unique in the oilseeds complex in that relatively little international made occurs with the seed; however, trade in cottonseed meal and oil is more important. Span and Mexico are the most important U. S. cottonseed markets, together taking 94 and 89 percent of U. S. exports in the August-July 1980-81 and 1981-82 marketing years, respectively. With total exports of 121,000 and 41,000 tons for these two years, cottonseed exports were valued at \$25 million and \$14 million, respectively.

Cottonseed deliveries to western states' oil mills continued to decline during the week ended January 12, according to the Cotton Division, Agricultural Marketing Service, USDA. Unfavorable weather and late stages of harvest kept down seed receipts. Grade certificates totaled 378 this week compared with 1,334 during the previous two-week period.

Of considerable interest in the United States in recent years is the increase in direct feeding of cottonseed, according to the Foreign Agricultural Service, USDA. The corollary to this is the relative decline in the proportion of the total domestic use of cottonseed that is crushed. In 1969-73, an average of 95.3 percent of the cottonseed used in the United States was crushed. In the last 5 years, crush averaged 82.2 percent of total use. In contrast, cottonseed in the "feed, seed, waste" category rose from an average of 4.7 percent of total domestic use during 1969-73 to an average of 17.8 percent in 1977-82. Feed, seed, and waste use of cottonseed reached its peak of 23.3 percent of total use in 1981, apparentin response to low prices. It is expected to decline to its second highest level of 20.3 percent this year. The large increase in direct feeding of cottonseed appears to have occurred in the mid-1970's; in 1975, "feed, seed, waste" constituted 4.6 percent of use; in 1976, it jumped to 15.9 percent. The shift in the cattle feeding industry to the Southern Great Plains and the increasing use of cottonseed in dairy feeding programs on the west coast may explain much of this rise.

Weather conditions delayed the harvest in western states during the period ended January 5, according to the Cotton Division, Agricultural Marketing Service, USDA. Receipts of cottonseed were on the increase in active harvesting areas of Texas and Oklahoma but had begun to taper off in other western states. Harvesting was in final stages to virtually completed over most of the remainder of the Belt. Grade certificates totaled 1,334 during the reporting period compared with 248 received the last week of December.

Prices paid growers for cottonseed ranged from \$60.00 per ton in Arizona to \$110.00 per ton in Texas. Oil mill prices for basis grade 100 cottonseed were mostly \$85.00 to \$90.00 per ton. "As is" prices ranged from \$70.00 to \$101.00 per ton. In some localities, cottonseed continued to sell to dairies and cattle feeders at prices above those paid by oil mills.

Cottonseed receipts at oil mills totaled 990,000 tons during November, bringing receipts for the season to 2,498,000 tons, according to the Bureau of the Census. This compares with 0,000 tons a year earlier and 2,028,000 tons two years ago. Oil mills crushed 481,000 of cottonseed during November, bringing crushings for the season to 1,448,000 tons. This was the largest crushings for the August-November period since 1965 and was up from 1,198,000 tons a year earlier and 1,427,000 tons two years ago. Oil mills had 1,831,000 tons of cottonseed still on hand at the end of November compared with 2,259,000 tons a year earlier and 1,659,00 tons two years ago.

Movement of cottonseed to western states oil mills decreased during the period ended December 21, according to the Cotton Division, Agricultural Marketing Service, USDA. Late harvesting made fair to good progress but was slowed by unfavorable weather in some localities. Grade certificates totaled 248 compared with 461 last week.

Process paid growers for cottonseed varied from \$65.00 to \$110.00 per ton, about the same as a week earlier. Oil mills paid ginners from \$70.00 to \$85.00 per ton, basis grade 100, and \$70.00 to \$101.00 per ton "as is". Some cottonseed continued to sell for animal feed at prices above those paid by oil mills.

Upland cotton ginned prior to December 1 this season totaled 8,825,792 running bales, according to the Bureau of the Census. This compares with 10,156,076 bales a year earlier and 7,840,476 bales two years ago. American Pima ginnings totaled 51,758 bales compared with 46,335 in 1981 and 52,509 in 1980. Ginnings through November this season were equivalent to a 76 percent of the expected production of 12,102,200 bales of 480 pounds net weight.

The <u>Cottonseed</u> <u>Review</u> will not be issued next week. The next issue will be released January 6 and will cover the two week period.

Cottonseed receipts at oil mills continued to decline, according to the Cotton Division, Agricultural Marketing Service, USDA. Rains delayed harvesting in most localities. Much of the expected volume of cottonseed has reached oil mills. Seed storage space was taxed in some heavy production areas. Cottonseed grade certificates received during the period totaled 812 against 1,322 a week earlier.

0il mill prices for basis grade 100 cottonseed were about unchanged and ranged from \$60.00 to \$85.00 per ton. "As is" prices ranged from \$70.00 to \$101.00 per ton. Prices ranged from \$30.00 per ton in Mississippi to \$110.00 per ton in Texas. Prices paid growers for seed to be used for animal feed were higher.

Cottonseed production, based on three-year average lint-seed ratio, was forecast at 4.81 million tons, compared with 6.40 million tons in 1981, according to the Crop Reporting Board, SRS, USDA.

ted States cotton production was forecast at 12.1 million 480 pound net weight bales, 1 percent above last month and 23 percent below 1981, according to the Crop Reporting Board, SRS, USDA. Upland production was forecast at 12.0 million bales and American Pima at 110,700 bales. Growers expect to harvest 9.41 million acres of upland and 72,700 acres of American Pima. Upland yield was forecast at a record 612 pounds and American Pima at 731 pounds.

Movement of cottonseed to oil mills slowed due to rains, wet fields and late stages of harvest, according to the Cotton Division, Agricultural Marketing Service, USDA. Harvesting neared completion in southern states. In western states, unfavorable weather slowed picking. Grade certificates received during the period totaled 1,322 against 2,002 a week earlier.

Gin yard prices for cottonseed were steady. Growers received from \$40.00 per ton in Alabama to \$110.00 per ton in Texas. Some gins sold cottonseed for cattle feed rather than crushing, and prices received were above those paid by oil mills. Oil mill prices for basis grade 100 cottonseed were about unchanged and ranged from \$60.00 to \$85.00 per ton. "As is" prices ranged from \$70.00 to \$145.00 per ton.

Cottonseed receipts at oil mills totaled 1,105,000 tons during October bringing receipts for season to 1,507,000 tons, according to the Bureau of the Census. This compares with 87,000 tons through October last season. Oil mills crushed 392,000 tons of cottonseed during October, the largest October crushings since 1972 and up from 340,000 tons a year earlier. Cumulative crushings through October this season were 968,000 tons compared with 727,000 tons a year earlier and 1,001,000 tons two years ago. Oil mills had 1,321,000 tons of cottonseed on hand at the end of October, the largest October stocks since 1977 and up from 1,257,000 tons last year.

Cottonseed moved to oil mills in heavier volume in western states and continued to slow in southern states during the week ended December 1, according to the Cotton Division, Agricultural Marketing Service, USDA. Final picking made little progress as rain and wet fields continued to delay the harvest in southern states. Soft field conditions made movement of module stored cotton to the gin difficult in some localities. In western states, harvesting also interrupted by wet weather. Cottonseed grade certificates totaled 2,002 this week pared with 1,789 last week.

Gin yard prices for cottonseed were steady and ranged from a low of \$40.00 per ton in Alabama to \$110.00 per ton in Texas. Oil mill prices for cottonseed were about unchanged and varied from \$60.00 to \$85.00 per ton, basis grade 100, with the lower range of prices mostly in southern states and the higher prices reported by mills in western states. "As is" prices ranged from \$70.00 to \$101.00 per ton.

Movement of cottonseed continued to slow in southern states during the period ended November 23, according to the Cotton Division, Agricultural Marketing Service, USDA. Rain and wet fields delayed picking in southern states where harvesting lingered in final stages. Ginning of stored seed cotton continued. Picking was expanding rapidly in Oklahoma and on the Texas Plains. Rains slowed the harvesting in the far west. Cottonseed grade certificates totaled 1,789, down from 2,416 a week earlier.

Oil mill prices for cottonseed were steady to unchanged and ranged from \$65.00 in most southern states to \$85.00 in western states, basis grade 100. "As is" prices ranged from \$70.00 per ton in Texas to \$101.00 per ton in California. The practice of using cottonseed for animal feed continued in some localities. Prices paid growers for cottonseed ranged from \$40.00 to \$110.00, mostly \$50.00 to \$70.00 per ton.

Forld oilseed production in 1982-83 is forecast at a record 184.9 million tons, up 0.9 milon from last month and 13.0 million above 1981-82, according to the Foreign Agricultural Service, USDA. Higher production estimates for sunflowerseed, rapeseed, cottonseed and palm kernel account for most of this month's upward revision.

World cottonseed production is forecast at 26.4 million tons for 1982-83, up 0.2 million from last month. Increases in the United States and China of 0.2 million tons each are partly offset by reduced estimates for the USSR, Australia and Thailand.

Cottonseed moved to oil mills at a slower pace in southern states, according to the Cotton Division, Agricultural Marketing Service, USDA. Harvesting in southern states neared completion but picking and ginning continued to increase in western states. Rain and fog slowed picking in the San Joaquin Valley of California. A hard freeze was received in most Texas, Oklahoma Plains areas. Cottonseed grade certificates received from licensed chemists totaled 2,416, down from 2,631 a week earlier.

Prices paid growers for cottonseed ranged from \$40.00 to \$101.00 per ton, mostly \$50.00 to \$70.00, about unchanged from last week. Cottonseed continued to move from gins for livestock feed rather than crushing in several areas. Oil mill prices for cottonseed ranged from \$65.00 to \$85.00 per ton, mostly \$65.00, in southern states and \$75.00 to \$85.00 in western states, basis grade 100. "As is" prices ranged from \$80.00 to \$84.00 per ton in Arizona and \$100.00 to \$101.00 in the San Joaquin Valley of California.

Lefted States oil mills produced 88.8 million pounds of cottonseed crude oil during Septem-, according to the Bureau of the Census. This was down from 92.0 million pounds in August. Stocks of crude oil at oil mills totaled 22.5 million pounds at the end of September compared with 17.5 million a month earlier. Cottonseed cake and meal production totaled 129,500 tons in September compared with 129,800 tons a month earlier. Oil mills had 153,600 tons of cake and meal on hand at the end of September, down from 185,500 tons at the end of August. Oil mills produced 77,700 tons of cottonseed hulls during September and had 62,800 tons on hand at the end of the month.

Cottonseed receipts tapered off in south central and southeastern states and increased in active harvesting areas of Texas during the week ended November 10, according to the Cotton Division, Agricultural Marketing Service, USDA. Rains slowed picking in some localities. Harvesting moved into late stages in southern states, expanded in Texas and reached peak proportions in Arizona and California. Cottonseed grade certificates totaled 2,631 during the week compared with 3,156 last week.

Gin yard prices for cottonseed were fairly steady and ranged mostly from \$55.00 to \$70.00 per ton. In some localities cottonseed being sold to use as cattle feed rather than crushing brought \$80.00 to \$120.00 per ton. Oil mill prices for basis grade 100 seed were mostly \$65.00 per ton.

Cottonseed receipts at oil mills totaled 261,000 tons during September, according to the Buou of the Census. This brought receipts for the first two months this season to 403,000 is compared with 472,000 tons a year earlier and 188,000 tons two years ago. Oil mills crushed 286,000 tons of cottonseed during September bringing crushings for the season to 577,000 tons. This was up from 387,000 tons a year earlier and down from 636,000 tons in 1980. Oil mills had 608,000 tons of cottonseed on hand at the end of September, up from 483,000 tons a year earlier but down from 610,000 tons two years ago.

Cottonseed moved to oil mills in heavier volume in western states and slowed in some southern states during the week ended November 3, according to the Cotton Division, Agricultural Marketing Service, USDA. Harvesting was in late stages in southern states. Rains delayed picking a few days during the reporting period. In the Far West, harvesting was gaining momentum. Cottonseed grade certificates totaled 3,156 compared with 3,041 a week earlier.

Oil mill prices for basis grade 100 seed were up slightly and ranged mostly from \$65.00 to \$70.00 per ton. Gin yard prices for cottonseed ranged from a low of \$40.00 per ton in Alabama to \$110.00 per ton in Texas. Most growers received from \$55.00 to \$70.00 per ton, about the same as last week. Some gins sold cottonseed for livestock feed at prices above those paid by oil mills.

World oilseed production for 1982-83 is now forecast at 184.0 million tons, down 800,000 tons from last month, but 12.3 million tons above 1981-82, according to the Foreign Agricultural Service, USDA. Lower prospects this month for the world soybean crop account for most of decline. World soybean production for 1982-83 is estimated at 97.9 million tons, down rly 700,000 tons from last month. However, the current crop is 13.6 percent above 1981-82 and 4.5 percent above the previous record in 1979-80. Soybean production forecasts were reduced nearly 400,000 tons in the United States and by 200,000 in Mexico. Reduced yields in a number of mid-western states account for the U. S. drop, while Mexico's crop was cut following damage from Hurricane Paul. World sunflowerseed production is forecast at 16.0 million tons, down 100,000 tons from last month, but 1.7 million above 1981-82. An increase of 300,000 tons for the USSR crop is more than offset by the reduction in the U. S. crop.

Cottonseed receipts increased sharply at oil mills during the week ended October 27, according to the Cotton Division, Agricultural Marketing Service, USDA. In some localities, notably the Mississippi Delta, seed receipts were very heavy and storage became a problem. In the Far West, movement of seed quickened as the harvest picked up momentum. Cooler weather and frost was received in some localities. Grade certificates received during the period totaled 3,041 compared with 1,801 a week earlier.

Gin yard prices for cottonseed were fairly steady and ranged mostly from \$50.00 to \$70.00 per ton. In some localities cottonseed going for animal feed rather than crushing brought \$80.00 to \$120.00 per ton. Oil mill prices for basis grade 100 seed were mostly within the \$65.00 to \$70.00 price range.

Consumption of edible cottonseed oil products totaled 53,727,000 pounds in August, according the Bureau of the Census. This is up somewhat from July's consumption of 42,184,000 peends. The largest proportion - 37,143,000 pounds - was consumed in salad or cooking oil. Fats used in baking or frying accounted for 14,205,000 pounds and 1,673,000 pounds were used in margarine. Around 706,000 pounds went into other edible products.

Oil mill receipts of cottonseed were off during the week ended October 20, according to the Cotton Division, Agricultural Marketing Service, USDA. The decline during this period reflected weather related harvesting delays in southern states. Harvesting was slowly gaining momentum in western states. Demand was fair to good for cottonseed products with the exception of hulls. Cottonseed received more interest for use in cattle feeding. Grade certificates received during the period totaled 1,801 compared with 3,389 a week earlier.

Growers received from \$40.00 per ton in Alabama to \$101.00 per ton in California for cottonseed at the gin. In most localities, prices were in the \$55.00 to \$70.00 price range. Hull prices also varied widely with prices as low as \$2.00 per ton reported for bulk sales in Mississippi. Oil mill prices for basis grade 100 cottonseed ranged mostly from \$65.00 to \$75.00 per ton across the Belt.

The total supply of crude cottonseed oil was 145.9 million pounds in August, according to the Bureau of the Census. This is down from 158.4 million pounds in July. Once-refined oil totaled 177.7 million pounds, also down somewhat from a month earlier when the supply totaled 184.2 million pounds. Reported August domestic consumption totaled 81.4 million pounds of crude cottonseed oil and 54.1 million pounds of once-refined oil.

Cottonseed receipts continued to increase at oil mills during the week ended October 13, according to the Cotton Division, Agricultural Marketing Service, USDA. Cotton harvesting was delayed by rains in the southern states and central Texas but ginning of stored seed cotton continued. In the Far West, harvesting was in initial stages. Grade certificates received during the period totaled 3,389 compared with 1,925 a week earlier.

Oil mill prices for cottonseed ranged from \$60.00 to \$80.00 per ton, basis grade 100 (mostly \$65.00 to \$75.00). Growers received from \$40.00 to \$90.00 per ton (mostly \$55.00 to \$70.00) at the gin.

Cottonseed production based on a three year average lint-seed ratio is forecast at 4.52 million tons compared with 6.40 million tons in 1981, according to the Crop Reporting Board, SRS, USDA.

Stocks of cottonseed oil totaled 153.7 million pounds at the end of July, according to the Bureau of the Census. Stocks included 53.0 million pounds of crude oil and 100.7 million pounds of refined oil. Both crude and refined stocks were up from June when stocks totaled 52.5 and 92.6 million pounds, respectively.

Cottonseed receipts at oil mills increased during the week ended October 6, according to the Cotton Division, Agricultural Marketing Service, USDA. Harvesting gained momentum in southern states and was in early stages in western and far western states. Grade certificates totaled 1,925 compared with 1,544 a week earlier.

Prices paid growers for cottonseed at the gin ranged from \$55.00 to \$80.00 per ton, mostly \$60.00 to \$70.00, on an "as is" basis across the Belt. Oil mills paid ginners mostly \$65.00 to \$70.00 per ton for seed, basis grade 100.

Cottonseed receipts at oil mills totaled 152,000 tons during the August 1-28 period, accordto the Bureau of the Census. This compares with 151,000 tons a year earlier and 84,000 tons two years ago. Oil mills crushed 291,000 tons of cottonseed during August compared with 196,000 tons in August last season and 330,000 tons in August two years ago. Oil mills had 643,000 tons of cottonseed on hand at the end of August, up from 353,000 tons a year earlier and down from 812,000 tons two years ago.

Harvesting gained momentum in southern states, reaching peak proportions in some localities during the week ended September 29, according to the Cotton Division, Agricultural Marketing Service, USDA. Elsewhere, ginning was virtually completed in south Texas and not yet underway in the Far West. Cottonseed grade certificates received this week totaled 1,544 against 424 a week earlier.

Prices paid growers ranged generally from \$60.00 to \$70.00 per ton across the Belt. 011 mills paid ginners \$70.00 to \$80.00 per ton, mostly \$70.00, basis grade 100.

Production of refined cottonseed oil totaled 92,233,000 pounds in July, according to the Bureau of the Census. This compares with 107,557,000 pounds in June. Consumption of both edible and inedible products totaled 42,696,000 pounds. Of the 42,395,000 pounds consumed in ble products, 10,992,000 pounds were consumed in baking or frying, 29,219,000 pounds in salad or cooking oil and 1,757,000 pounds in margarine.

Cottonseed movement to oil mills increased during the week ended September 22, according to the Cotton Division, Agricultural Marketing Service, USDA. Picking and ginning remained steady in central Texas and increased significantly in most southern cotton states. The number of cottonseed grade certificates received from licensed chemists nearly doubled to 424 compared with 244 the previous week.

Southern states: Cotton gins paid growers \$60.00 to \$75.00 per ton for cottonseed, mostly \$60.00 to \$70.00. Oil mills paid gins \$70.00 per ton, basis grade 100.

Western states: Growers received 65.00 to 90.00 per ton for cottonseed with an average of 72.50 per ton. Oil mills paid gins 80.00 per ton, basis grade 100 and 75.00 per ton "as is".


Cottonseed receipts at oil mills totaled 5,014,000 tons during the 1981-82 season. This was a largest receipts for any season since 1972-73 and was up from 3,415,000 tons a year earlier and 4,768,000 tons two years ago. Oil mills crushed 4,631,000 tons of cottonseed in 1981-82, the largest since 1973-74 and up from 4,076,000 tons in 1980-81 and 4,230,000 tons in 1979-80. Oil mills had 780,000 tons of cottonseed on hand at the end of July, up from 398,000 tons a year earlier but down from 1,058,000 tons two years ago.

Only a few gins remained in operation in south Texas as the harvest was almost completed, during the week ended September 15, according to the Cotton Division, Agricultural Marketing Service, USDA. Only a small amount of module stored seed cotton remains to be ginned. Light to heavy rains stopped picking in southeastern and south central states where a sizeable acreage has been treated with defoliants. Cottonseed grade certificates received this week totaled 244.

Prices paid growers for cottonseed ranged generally from \$70.00 to \$75.00 per ton in Texas on an "as is" basis. Oil mills paid Texas ginners around \$80.00 per ton for seed, basis grade 100. Cottonseed grades ranged from 81.5 to 105.0 in Texas, 81.0 to 103.0 in Arkansas, 97.5 to 100.5 in Georgia, 52.0 to 100.0 in Louisiana, 94.5 to 102.5 in Mississippi, 89.0 to 93.5 in Missouri and 80.0 to 101.5 in Tennessee. Wholesale prices in Texas for 41 percent protein cottonseed meal varied from \$160.00 to \$190.00 per ton sacked and \$140.00 to \$178.00 per ton k. Bulk hulls traded from \$20.00 to \$35.00 per ton and sacked hulls at \$60.00 per ton.

Cottonseed production for 1982, based on a three year average lint-seed ratio, was forecast at 4.39 million tons. This is about 31 percent below 1981 production.
