In the first month, students were eligible to apply for up to \$500 for food, housing, technology, course materials, or other expenses related to the disruption to campus in Spring 2020.
 - b. Texas Tech University is using an application process for eligible students to request funds for the emergency grants to students. In the second month, students were eligible to apply for up to \$750 for food, housing, technology, course materials, or other expenses related to the disruption to campus in Spring 2020.
 - c. Some students were selected in a block grant for \$500. Most students in the block grant were paid from CRRSSA funds.
 - d. Block grants were awarded to all students who had an EFC of 10,000 or less as the federal guidelines indicated that students who had "exceptional financial need" should be prioritized.
