TTU/TTUHSC INTER-INSTITUTIONAL ARTICULATION AGREEMENT – (Addition)
Description:

The institutions, Texas Tech University Health Sciences Center, on behalf of its School of Nursing (TTUHSC), and Texas Tech University, on behalf of its Jerry S. Rawls College of Business (TTU), will jointly administer a dual-degree program in which eligible students can earn two degrees, a Master of Science in Nursing and a Master of Business Administration (MBA) with concentration in Health Organization Management (HOM) (this will be referred to herein as "the Program").
