AT&T Inc., formed in November 2005, from the merger of SBC Communications Inc. and AT&T Corp. (Ticker Symbol: T) is globally headquartered in Dallas, Texas, with more than 276,280 employees worldwide. The new AT&T is the largest communications holding company in the world by revenue.

As a Fortune 500 company, AT&T is one of the 30 stocks comprising the Dow Jones Industrial Average, with stock traded in New York, Chicago, Pacific and Swiss exchanges and on the London Stock Exchange through the SEAQ International markets facility. The primary U.S. Operating Regions are California, Nevada, Texas, Oklahoma, Kansas, Arkansas, Missouri, Louisiana, Mississippi, Alabama, Georgia, Florida, South Carolina, North Carolina, Tennessee, Kentucky, Michigan, Ohio, Illinois, Indiana, Wisconsin, and Connecticut. AT&T also provides customers with the freedom to make wireless calls using an internationally enabled phone on six continents and in more than 220 countries. AT&T is the nation's largest Wi-Fi provider, offering customers access at over 125,000 hot spots spanning countries around the world.

AT&T provides voice and data telecommunications products and services for consumers and businesses.

AT&T traces its roots to the original Bell Telephone Co. and has served customers since the birth of the telecommunications industry. In March 2006, AT&T announced its intention to acquire BellSouth Inc. The approximately \$86 billion merger was approved by the Federal Communications Commission on December 29, 2007, creating the industry's most effective and efficient provider in the wireless, broadband, video, voice and data markets.

AT&T companies and their employees are committed to enriching and strengthening America's diverse communities through financial support and millions of volunteer hours. The new AT&T Foundation combines over 40 years and more than \$2 billion in philanthropic commitment to communities across the country. Chairman and CEO and lead SBC through a series of mergers and acquisitions until his retirement on June 4, 2007 after forty-four years of service.

Randall L. Stephenson is the current Chairman of the Board, Chief Executive Officer and President of AT&T. Mr. Stephenson has served in this capacity since 2007. From 2004 until his appointment as the Chief Executive Officer, Mr. Stephenson served as the Chief Operating Officer of AT&T and as the Chief Financial Officer from 2001 to 2004. He has been with AT&T since 1982. He also currently serves as the Chairman of the Executive Committee and has been a director of AT&T since 2005. Mr. Stephenson is also on the board of directors for Emerson Electric Company. Mr. Stephenson graduated with a B.S. in Accounting from Central State University in Wilberforce, Ohio, and received a Master of Accountancy from the University of Oklahoma.
