Board of Regents October 31, 2011

Monday, October 31, 2011.—The members of the Board of Regents of the Texas Tech University System convened in a special-called meeting by teleconference at 5:31 pm. On Monday, October 31, 2011, in the Board Room, Room 201, Second Floor, Administration Building, Akron and Broadway Avenues, Texas Tech University, Lubbock, Texas, with the following in attendance:
