## ABOUT THE EXAM

The examination for the second semester of Algebra I consists of 40 multiple choice and problem-solving questions. The exam is based on the Texas Essential Knowledge and Skills (TEKS) for this subject. The full list of TEKS is included in this document (it is also available online at the Texas Education Agency website). The TEKS outline specific topics covered in the exam, as well as more general areas of knowledge and levels of critical thinking. Use the TEKS to focus your study in preparation for the exam. TEKS covered in this semester are indicated by a checkmark; the exam will focus on the checkmarked TEKS, but may touch on any of the full list.

The examination will take place under supervision, and the recommended time limit is three hours. You may not use any notes or books. A percentage score from the examination will be reported to the official at your school.

A list of key concepts is included in this document to focus your studies. It is important to prepare adequately. Since questions are not taken from any one source, you can prepare by reviewing any of the state-adopted textbooks that are used at your school. The textbook used with our ALG 1B course is:

## ALG 1B Key Concepts

- Solve quadratic equations having real solutions by factoring, taking square roots, completing the square, and applying the quadratic formula.
- Write, using technology, quadratic functions that provide a reasonable fit to data to estimate solutions and make predictions for real-world problems.
- Determine the domain and range of exponential functions of the form $f(x)=a b^{x}$ and represent the domain and range using inequalities.
- Interpret the meaning of the values of $a$ and $b$ in exponential functions of the form $f(x)=a b^{x}$ in real-world problems.

- Add and subtract polynomials of degree one and degree two.
- Multiply polynomials of degree one and degree two.
- Determine the quotient of a polynomial of degree one and polynomial of degree two when divided by a polynomial of degree one and polynomial of degree two when the degree of the divisor does not exceed the degree of the dividend.
- Rewrite polynomial expressions of degree one and degree two in equivalent forms using the distributive property.
- Factor, if possible, trinomials with real factors in the form $a x^{2}+b x+c$, including perfect square trinomials of degree two.
- Decide if a binomial can be written as the difference of two squares and, if possible, use the structure of a difference of two squares to rewrite the binomial.
- Simplify numerical radical expressions involving square roots.
- Simplify numeric and algebraic expressions using the laws of exponents, including integral and rational exponents.
- Identify terms of arithmetic and geometric sequences when the sequences are given in function form using recursive processes.
- Write a formula for the $n^{\text {th }}$ term of arithmetic and geometric sequences, given the value of several of their terms.
