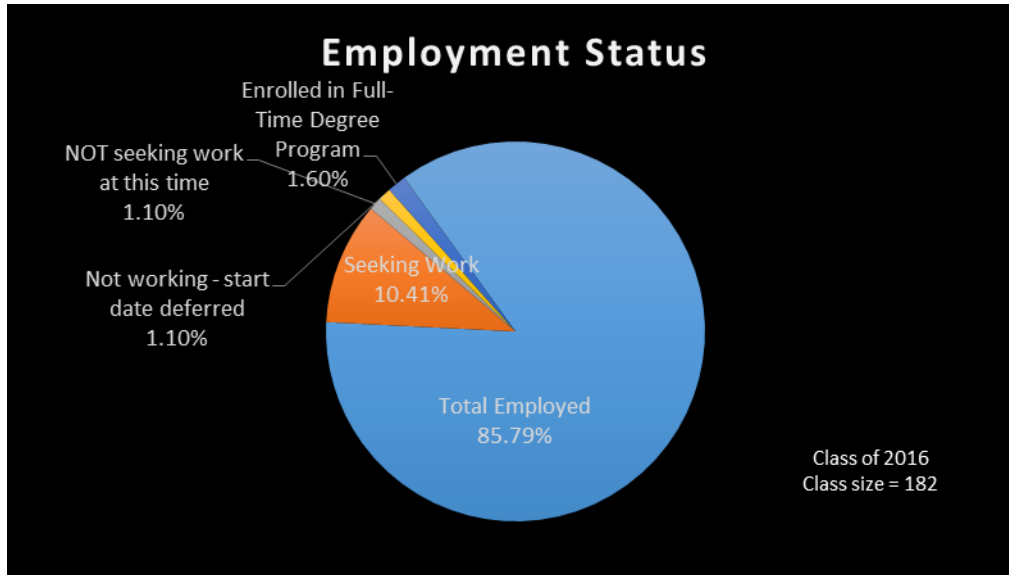

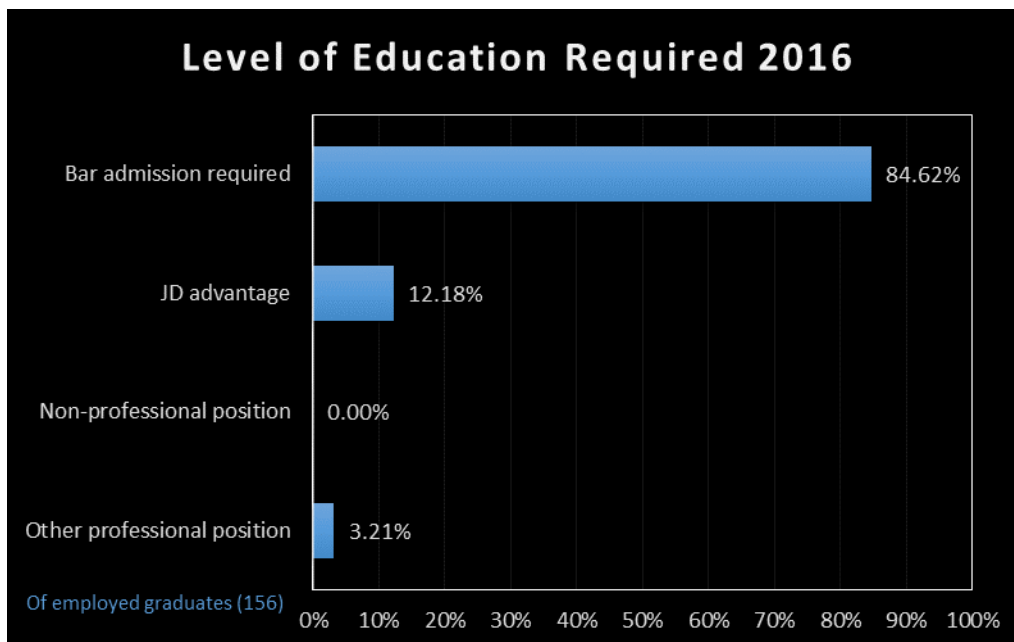

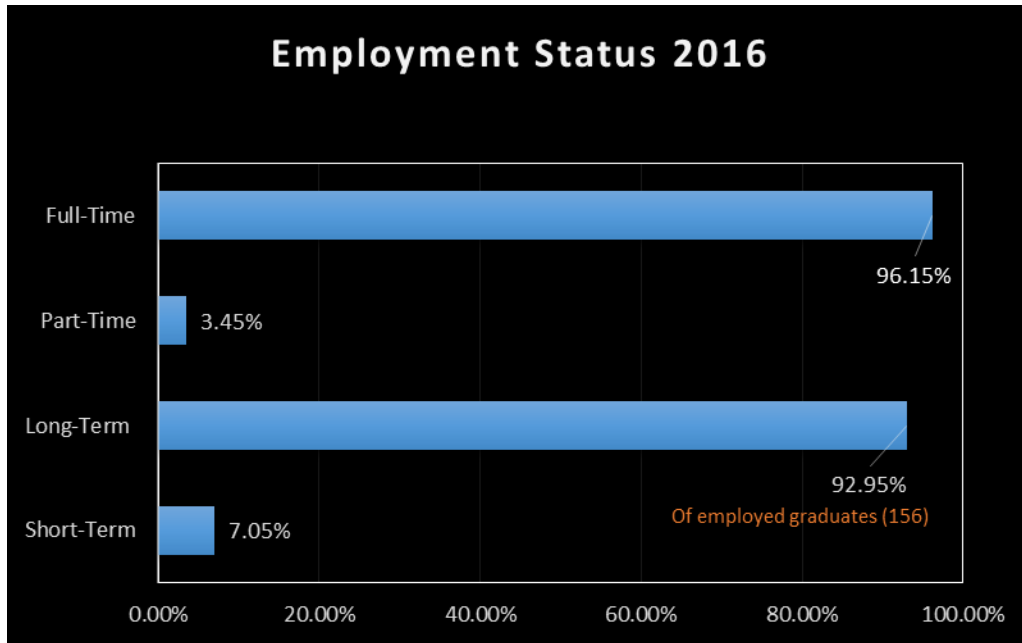
### Texas Tech Law Class of 2016 Employment Status ten months after graduation (as of March 15, 2017)



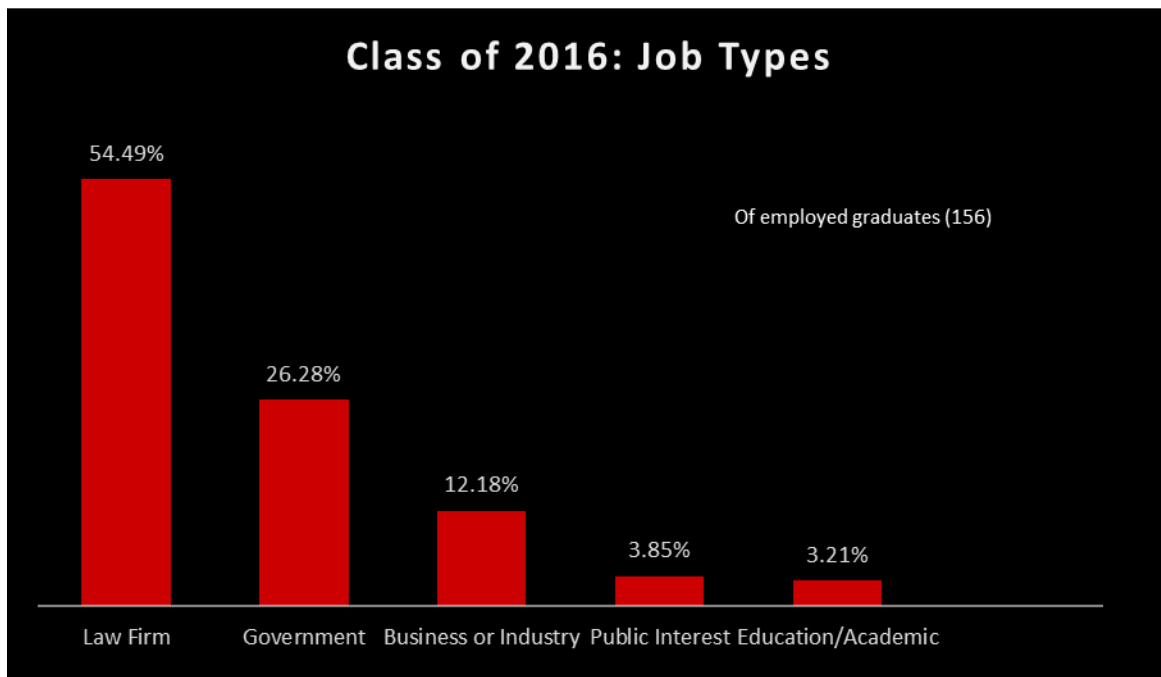
### Texas Tech Law Class of 2016 Employment by Education Required

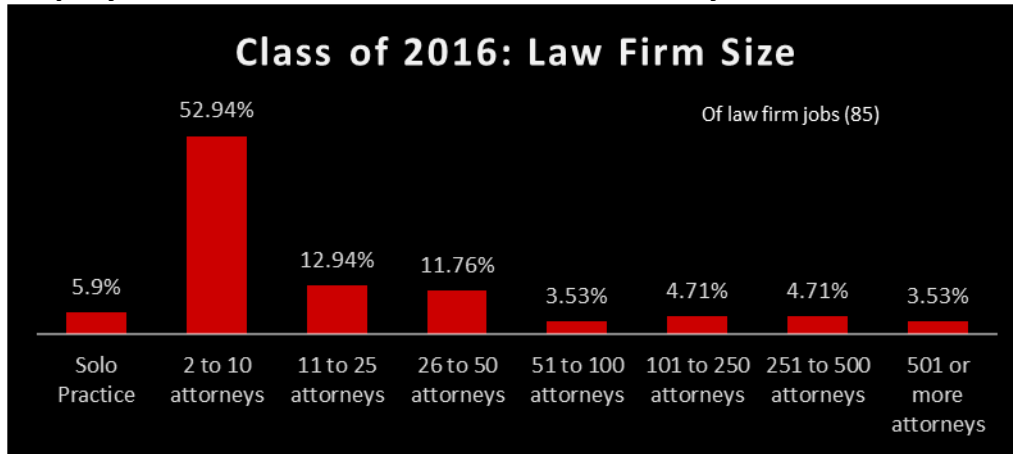

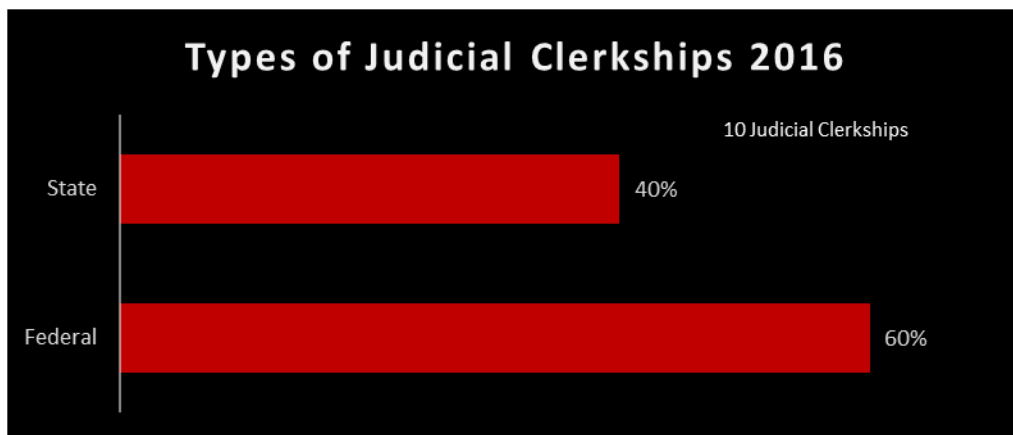

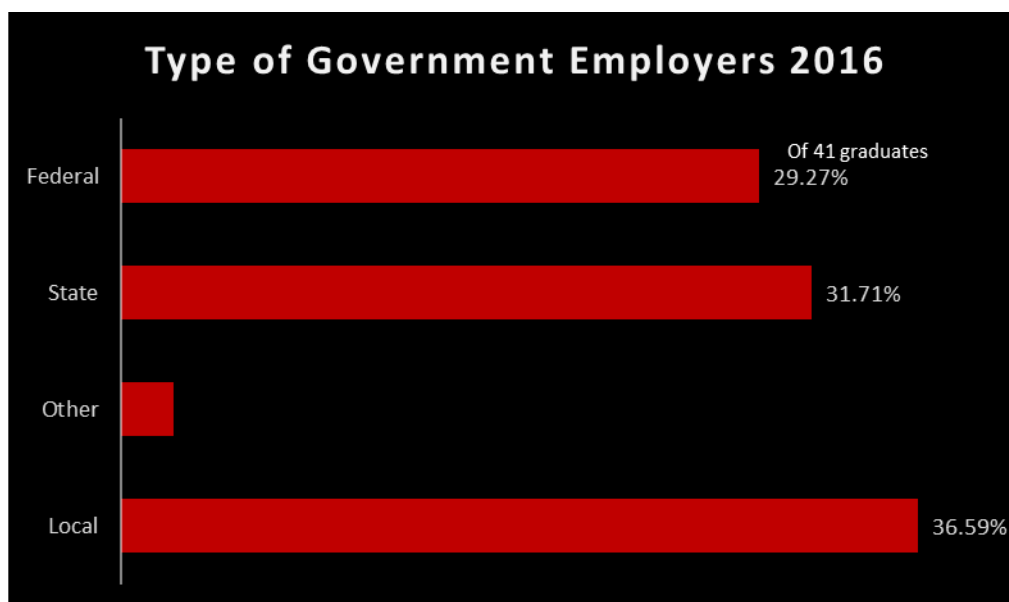

## Texas Tech Law Class of 2016 Employment Information for Judicial Clerkships



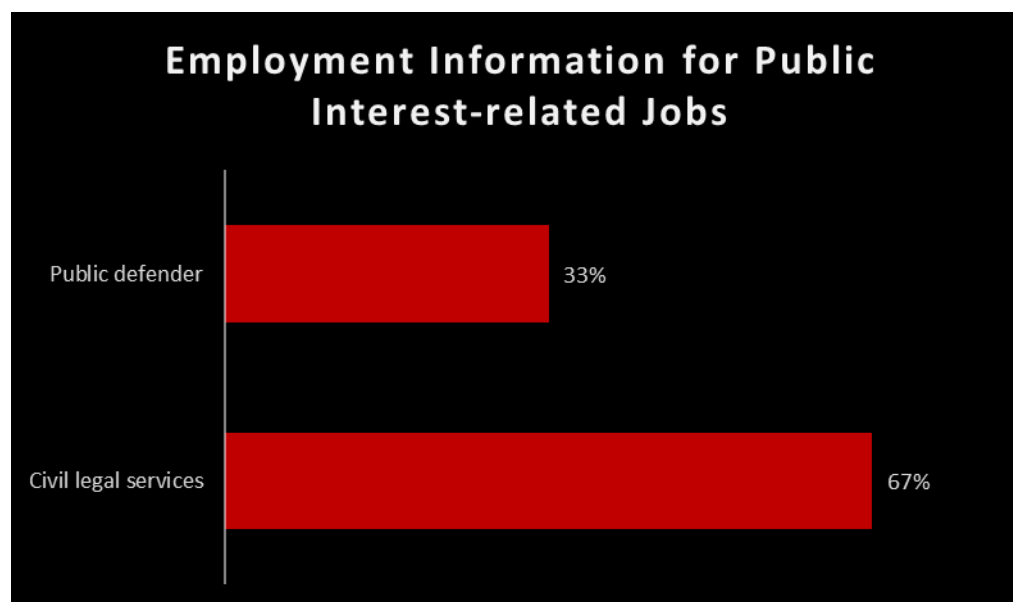
## Texas Tech Law Class of 2016 Employment Information for Government Employers (including judicial and military)

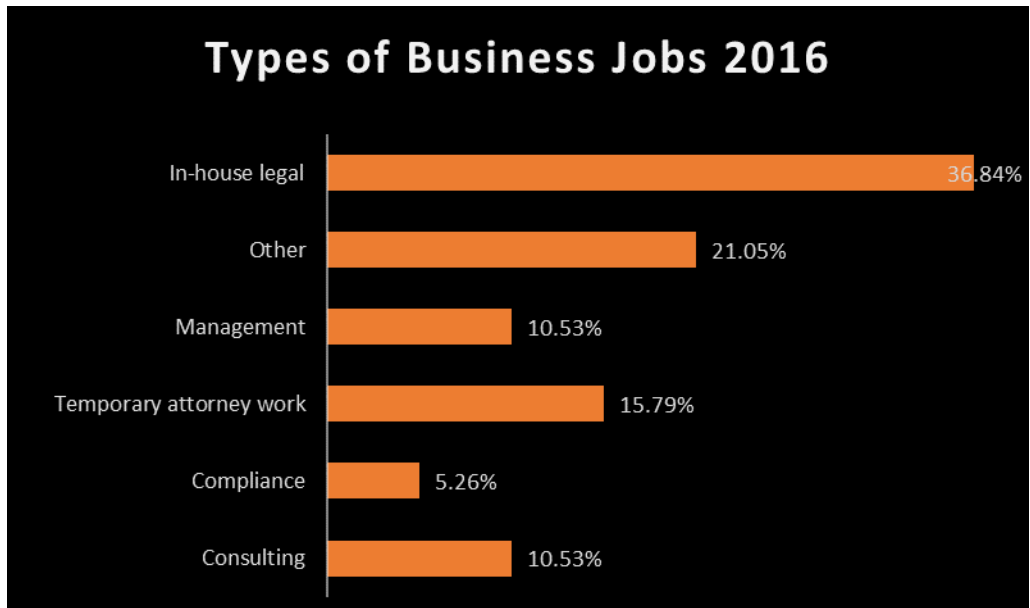
