## Each nomination must include the following documentation:

- 1. This **Honorary Degree Nomination Form** with signatures of nominator and dean.
- 2. Nomination Statement:
  - The following are among factors and attributes that should be considered during a review of nominations for an honorary degree:
    - What is the specific content of the nominee's contribution?
    - Of all possible contributors to the field of endeavor, why is this nominee of exceptional merit?
    - Why is the field of the nominee especially appropriate to TTUS?
  - In all honorary degree candidates, the person's scholarly, creative, professional, service, or occupational achievements should be placed in a framework of high personal integrity, character, and concern for the public good.
- 3. Supporting Letters (at least two) from qualified recommenders who are familiar with the professional accomplishments and achievements of the nominee.
- 4. Resume or Vita of nominee
- 5. Other supporting materials as deemed necessary by the nominator.

Information should be complete so that the committee will be able to arrive at a decision based on the material submitted. Incomplete nominations cannot be reviewed by the committee and will be returned to the Dean's office.



Care should be taken so that candidates are **not** aware of their nomination.
