# From the Director's Desk

September 13, 2012

Greetings from Lubbock. The MPA program continues to evolve and grow. To reflect the nation's and the university's increasing involvement in environmental teaching and research, we added a new faculty member this fall to teach environmental courses. We are excited to be part of this movement, and we bring a management and policy orientation to the environmental table. We are considering the establishment of an environmental management track for our program.

Our student population continues to be stable. We bring in about the same number of students we graduate. During the academic year, 17 students completed their program requirements and were added to the growing list of alumni. At the time I am writing this, 26 have been admitted and 6 more are in various stages of completing their admission applications. With our new admissions, we have 58 students. Our largest concentration is public management with almost half our students in that track. Our second highest concentration is Nonprofit management, which is a track that was just added two years ago. We also have a good representation of students who are working on a dual MPA/JD program. Interest in public administration as a field from the political science Ph.D. students is also growing.

service and has made a distinct contribution to the betterment of society. and international levels. In addition to on-the-job training, the PHPS program provides formal instruction in program management, epidemiology, surveillance, emergency response, and program evaluation. PHPS fellows participate in a variety of activities, such as seminars, evaluation projects, Web-based training, temporary duty assignments, and conferences, which are designed to teach essential public health program management skills.

The fellowship focuses on public health program management and provides experience in program planning, implementation, and evaluation through specialized hands-on training and mentorship at CDC, and in state and local health organizations. Fellows start with two 6-month rotations at the CDC in Atlanta, Georgia or one of the other CDC locations. The next two years, fellows spend their time in a field assignment with a public health agency.

**Dr. Robert E. Forbis Jr.** is a visiting assistant professor of political science and the Master of Public Administration Program (MPA). He teaches courses on: Environmental Politics and Policy, Environmental Administration, Environmental Law and Regulation, Public Lands and Resource Law and Policy, Energy Law and Policy, Sustainability Policy, and Environmental Justice.

Professor Forbis' research focus is an ongoing exploration of the energy development and environmental protection policy nexus. His research specifically addresses political conflicts derived from the "fracking" process of Coal-Bed Methane Natural Gas (CBM) development as well as other forms of domestic energy development initiatives. His dissertation drew upon on policy subsystem theory to identify conditions under which stakeholders within the Bureau of Land Management's policymaking environment strategically responded to the political conflict that emerged from the modern-day federal expansion of CBM energy development in the states of the Rocky Mountain West.

Prior to his arrival at Texas Tech Dr. Forbis was an assistant professor at Idaho State University. He earned his Doctorate in Political Science from



the University of Utah, Master of Public Administration from the University of Utah, and Bachelor of Arts from the University of Texas-Austin.

#### Dr. Carie Steele

Dr. Steele joined the MPA faculty in Fall 2011. She began the year by attending the 2011 American Political Science Association Conference in Seattle, Washington in September. There she presented a paper entitled "Disease Control and Donor Priorities: The Political Economy of Development Aid for Health." This paper originated from her dissertation, for which she won the University of Illinois, Department of Political Science Burkholder Award for Best Dissertation in 2011. In March, Dr. Steele attending the 2012 Midwest Political Science Association Conference in Chicago, Illinois. There she presented a revised version of "Disease Control and Donor Priorities: The Political Economy of Development Aid for Health" as well as a new project titled "International Cooperation and Domestic Preservation: The Political Economy of World Heritage Site Nomination and Inscription." In April, Dr. Steele conducted field work in Nambia --- interviewing policy-makers in Windhoek as well as visiting rural areas to visit clinics and speak with patients and healthcare workers. The results of this work were presented at the 2nd annual European Political Science Association Conference in Berlin, Germany in June. Dr. Steele continues to teach MPA courses related to policy analysis and health policy.

#### **Evaluation of a Public Defender Office**

# This evaluation was completed by graduate public administration students at Texas Tech University under the direction of Dr. David K Hamilton for the Texas Indigent Defense Commission

This is a summary of the evaluation of the Public Defender's Office in a county in the Dallas area. The office was instituted in 2007 after county judges and commissioners recognized a need to find solutions to curb the rising cost of indigent defense services. The county was awarded a grant from the Texas Indigent Defense Commission to help create a public defender's office. This office is administered by a Chief Public Defender, along with two other assistant public defenders, and they handle about 30% of the indigent defense cases of the county.

The evaluation team used both quantitative and qualitative methodologies to evaluate the effectiveness of the office and the overall indigent defense in the county. The team used the data in statistical analyses to test hypotheses on whether the public defender had improved indigent defense services in the county. Qualitative analysis was based on interviews conducted with several stakeholders including County judges, the District Attorney, the Justices-of-the-Peace, among others. The evaluation analyzed the Public Defender's Office and the overall indigent defense system on each of the objectives stated in the grant submission.

The team's conclusions from the analysis are that the Public Defender's Office has made a difference in indigent defense. Indigent defendants have been given immediate access to legal services. Second, the Public Defender's Office has also met the objective of improving the speedy disposition of felony cases or cases in which

the defendant is not able to post bond. However, it has not made a difference in the processing speed of misdemeanor cases from arrest to disposition.

The analysis showed that since the establishment of the Public Defender's Office, the amount of jail time for those arrested on felony charges has been dramatically reduced. However time spent in jail for those facing misdemeanor charges has remained relatively static.

Although total indigent costs have increased, the number of new cases filed has increased by a similar percentage. Indeed, the average cost per case has decreased from the base year before the establishment of the Public Defender's Office in all except one year studied. Public defender costs per case were also lower than assigned counsel in two of the three years studied. In addition, the reduction of jail time and jail population has saved the county money. We attribute the reduced jail time and savings, at least partially, to the reduced amount of time to process defendants through the system. Indeed, the jail has been able to realize increased revenue by accepting prisoners from other jurisdictions.

Due to deficiencies in the data collected from the files, the original sample size of 300 cases was reduced to 224 cases. The report recommended that the collection of data and recordkeeping be improved so that there is accuracy and consistency in District and County Court records. The team also recommended that the county should consider moving to an automated and integrated electronic system to manage and track defendants through the system. The system should link the justice-of-the-peace precincts, the jail system, the district attorneys, public defenders, indigent defense coordinator, investigator, district and county clerks and attorney. An integrated system should improve case information, increase uniformity, and improve access by users. Moreover, the county could realize improved efficiencies through data sharing. Moreover, the team recommended that the Public Defender be assigned more felony cases as the analysis indicated that the office handled felony cases more efficiently than assigned counsel. Felony defendants receive less jail time and faster processing through the court system with the Public Defender than through assigned counsel. The team felt that the Public Defender's Office also provided more consistent investigative research and support to indigent clients through its on-staff investigator. Auditor reports showed that the payments for investigative work varied during the years studied and seemed to be inadequate, given the number of cases handled by assigned counsel.

Finally, the team felt that there were efficiencies that could be achieved in the Public Defender's Office. One objective of the grant was to reduce indigent defense costs. The team felt that investigative services are an extremely important function and this position should continue. There are two office support staff to service an investigator and three attorneys. The team questioned the need for two office staff and recommended that the office reduce the office staff by one to affect some savings. If needed, the office could hire temporary staff as necessary to assist in the office function.

# The Master of Public Administration Program

The Master of Public Administration (MPA) provides professional knowledge and skills-based competence for working public administrators or students seeking a career as a manager or policy analyst in public or nonprofit agencies. Recipients of our degree enter the job market equipped with general public management skills and a specialization in a particular public sector or policy area such as non-profit management, fiscal administration, health administration, and health policy among others. The MPA is conferred and administered by the Department of Political Science in conjunction with the Center for Public Service.

At Texas Tech, we are deeply concerned about teaching as well as research, and we offer a quality education with a high degree of interaction among faculty and students.
