

## ***Student Financial Aid and Scholarships Terms & Conditions***

Eligibility for financial aid is reviewed annually based upon

- Timely completion of the Free Application for Federal Student Aid (FAFSA) along with submission of any additional required documents
- Financial need (resulting from annual review of family income/assets, household size, number of family members attending college, etc.)
- At least half-time enrollment in a degree-seeking program
- Satisfactory Academic Progress (SAP) as outlined on the Student Financial Aid & Scholarships website

Availability of financial aid is determined by annual state and federal allocations and program guidelines and is offered for one academic year at a time on a first-come-first-served basis.

Federal and state financial aid may only be used to pay for the cost of attending an institution of higher education, which includes direct costs (tuition, fees, etc.) and indirect costs (books, supplies, transportation, etc.).

Texas Tech University will notify you of financial aid related information (including changes to your eligibility) through your **Texas Tech University email address**.

### **Enrollment**

- Financial aid eligibility is determined with the assumption of your attendance at Texas Tech University for the entire period for which financial aid is offered.
- Most types of financial aid require at least half-time attendance in a degree-seeking program
- Cost of attendance used to determine your financial aid eligibility is based on the enrollment indicated on your Expected Enrollment Form. Changes to your cost of attendance may be made by contacting the Student Financial Aid & Scholarships at [finaid.advisor@ttu.edu](mailto:finaid.advisor@ttu.edu).
- In addition to your credit hour enrollment, the college which you are enrolled in is used to determine your cost of attendance once 60 earned credit hours has been accumulated. Contact the Office of Financial Aid at [finaid.advisor@ttu.edu](mailto:finaid.advisor@ttu.edu) regarding changes to your college.
- Federal regulations specify that a student may receive federal aid for only one repetition of a previously passed (grade of "D" or higher) course. Evaluation of federal financial aid eligibility for repeated courses is conducted each semester.
- Withdrawal from Texas Tech University after the semester begins may result in a requirement to repay financial aid funds to the university.
- Earning a grade of "F" in all registered courses in a semester may result in a requirement to repay financial aid funds to the university.

### **Satisfactory Academic Progress (SAP)**

Federal regulations require that all financial aid recipients maintain Satisfactory Academic Progress (SAP) toward completing their degree in order to receive financial aid.

- SAP applies to all federal, state, and university aid programs and is evaluated at least annually (more frequently for those who are not meeting SAP).

### **Verification**

Federal verification is a process which requires institutions to verify the accuracy of the information provided on the FAFSA of randomly selected applicants in an effort to ensure federal aid is distributed to those who are eligible. If your FAFSA is selected for verification by the U.S. Department of Education (ED), you are required to provide documentation to the school in order to verify the information provided on the FAFSA.

- After submitting your FAFSA, you will receive an electronic Student Aid Report (SAR), which will indicate if you have been selected for federal verification. In addition, you will receive notification from Student Financial Aid & Scholarships regarding the required documentation that must be submitted in order to satisfy the federal verification requirement.

- No disbursements of financial aid will be made until all verification requirements have been submitted and processing is complete.
- Failure to submit verification requirements could result in a cancellation of your financial aid and future financial aid eligibility would be based on the availability of funds at the time verification has been completed.

### **Grant & Scholarship Assistance**

- Full-time enrollment is assumed when need-based grants are offered. Each semester, grants will be subject to proration (or in some cases cancellation) if enrollment drops below full-time.
- Any scholarships or grants not included on your financial aid notification must be reported to Student Financial Aid & Scholarships.
  - Receipt of scholarships, tuition assistance/fee waivers, graduate fee waivers, 3rd party payments, or any other form of assistance may require a reevaluation of your financial aid eligibility. Every attempt is made to reduce loans first, but in some cases other need-based aid such as grants or federal work-study will need to be reduced.
- Scholarship recipients authorize Texas Tech University to publicly acknowledge/recognize them as an award winner to the original donor(s) of the scholarship or their designees, at any Texas Tech University award event and on any Texas Tech University website.
- Scholarship recipients also consent to the public release of such information to parents, private and public media, and other publications (including video, newspapers, magazines, etc.)
- In addition, scholarship recipients understand and accept that as a condition of the scholarship, they may be required to write and send a personal thank you letter to the donor(s) of the scholarship or the selection committee.
- If scholarship recipients wish that their scholarship be kept confidential, they must submit that request in writing to the institutional department awarding their scholarship.

### **Borrowed Assistance**

Subsidized and Unsubsidized Federal Direct Loans are offered, based on eligibility to students who have submitted a FAFSA and completed the financial aid application process.

- Loans may be declined by the student at any time before loan funds have disbursed by contacting the Student Financial Aid & Scholarships at [finaid.advisor@ttu.edu](mailto:finaid.advisor@ttu.edu). No origination fee, guarantee fee, or interest will be charged on the amount of the loan that is declined.
- Loans may be cancelled (partially or entirely) by informing the Student Financial Aid & Scholarships within 14 days after date of the disbursement notice (or by the first day of Texas Tech University's payment period, whichever is later). If all or a portion of my loan is cancelled, the cancelled amount will be returned to the U.S. Department of Education and the loan fees will be reduced or eliminated in proportion to the amount returned.

### **Earned Assistance**

Federal Work-Study is a need-based work program for students who demonstrate eligibility through submission of the FAFSA.

- A job or earnings are not guaranteed and a position with a hiring department must be secured by the student before an offer of Federal Work-Study eligibility will be made.
