A. Selected items from minutes of Academic Council Meetings

April 22, 1980

- 1. There was discussion of temporary faculty and whether additional policies need to be developed as regards personnel who come into non-tenure track positions. There was discussion, without action, of the need for limiting the number of temporary or non-tenure track positions and the possibilities of individuals filling those positions applying for regular positions as they become available.
- 2. The final examination policy was reaffirmed and it was pointed out that a committee of the Faculty Senate has also recommended continuance of the policy. Assistance was asked in getting a survey completed regarding the number of finals, in organized classes, being given for the spring semester.
- 3. Deans were reminded that exit interviews are expected for each departing faculty member. The policy and procedure for those interviews has been communicated previously.

- 2. Drs. Hardwick and Jones discussed opportunities for interdisciplinary study and involvement. Ideas were requested with regard to mechanisms for communication regarding interdisciplinary programs.
- 3. There was a discussion of a proposal for the use of "soft monies" for faculty salaries. A number of ideas were discussed as to how research and project funds could be used to augment existing faculty salaries. Suggestions were requested so that a proposal could be developed for testing during the coming year.
- 4. Dr. Hardwick emphasized the need for maintaining realistic records regarding faculty evaluations since tenure decisions need to rest on accumulated evidence. Deans were asked to continue to work with chairpersons to develop a substantial record base on which tenure recommendations could be made.
- 5. Previously distributed materials regarding chairholder selection and the impact of removal of non-tenured track full-time faculty positions were carried forward for discussion at a subsequent meeting.

- 9. President Cavazos, responding to his refusal to create a standing committee on energy usage at the present time, also inviting him to attend the May 7, 1980, Senate meeting.
- 10. To all members of Standing Study Committees A, B, and C, thanking them for their service.

May 14, 1980

1. A task force on academic counseling was initiated by Dr. Hardwick. He proposed a continuing study of the academic counseling of the University and appointed Dean Sam Curl as chairperson and Dean Carl Stem to work with a representative of the Faculty Senate and the Student Association in conducting the study.

Dr. Hardwick asked the task force: to détermine what is being done (by college) in the general area of advisement, to suggest ways to improve the advisement system, and to consider whether the institution should install a general orientation course. Since an orientation course has been suggested for provisionally admitted students, the feasibility of that course of action is also to be considered.

There were a number of suggestions related to the task force review of advisement, including the need for full-time college based counselors to initiate and follow-up direct contacts with students, assigning a freshman advisor, and in looking at ways in which attrition might be reduced. It was suggested that since academic advisement is primarily a faculty matter, that this be referred to the Faculty Senate to enlist full scale faculty involvement in the provision of services to students and to reduce unwarrented attrition.

- 2. A draft of a position paper regarding the development of research incentives was distributed. Deans were asked to read the paper, prepared by Research Services, and be ready to discuss it at the next Academic Council meeting.
- 3. There was discussion of the recommendations of the Tenure and Privilege Committee regarding non-tenure track and temporary positions. Deans expressed concern that considering all faculty positions to be tenure-track or tenured would sharply limit flexibility in the University. Deans were asked to as sess the impact such change would make on each individual college and to provide information in writing to the Academic Affairs office before the next Academic Council meeting.

There was some attempt at clarification regarding the intent of the resolution and it was decided to accept the definition that any individual paid full-time by Texas Tech who teaches at least part-time, should be considered in the analysis made by dears regarding the impact of such policy.

May 28, 1980

1. Dads Association director, James G. Allen, described a plan for a Visiting Professorship project of the Association. ## RESOLUTION CONCERNING THE ATHLETIC COUNCIL AT TEXAS TECH UNIVERSITY

WHEREAS the Faculty Senate established, in its meeting of March 22, 1980, a committee charged with determining whether Texas Tech has been in compliance with the rules of the Southwest Athletic Conference, and

WHEREAS that committee has completed its task and has reported that Texas Tech University has not been in compliance with the provisions of Article III of the Southwest Athletic Conference Constitution since 1977,

BE IT RESOLVED that the President of Texas Tech University is hereby urged to restore the Athletic Council to its former, proper role of reviewing and recommending to him on all important issues relevant to the policies and administration of the intercollegiate athletic program, "and

BE IT FURTHER RESOLVED that the length of appointment of faculty to the Athletic Council be restored to three years' duration, with terms staggered in order to provide continuity. Agenda item IV

#### RESOLUTION CONCERNING LARGE LECUTRE HALL ON CAMPUS

WHEREAS faculty members in several departments are required to hold large classes in lecture halls in many locations on campus, and

WHEREAS numerous faculty members have complained about the inadequacy of some of those lecture halls with regard to acoustical problems, blackboard space, the use of electric audio-visual equipment, physical comfort, and external noises,

BE IT RESOLVED that the appropriate administrative officer of the university be encouraged to conduct an investigation into the inadequacies of the large lecture halls on campus, and recommend that remedial action be taken. Such investigation should include, but not limited to, careful inspection and interviews with faculty members who have used those lecture halls in the past.
