- 3. At its March 25 meeting the TTU Board of Regents approved the proposed changes in traffic and parking regulations allowing faculty to park in any 24-hour reserved space.
- 4. Wrote letter congratulating Professor Walter Cartwright on his appointment to the Faculty Senate Elections Committee.
- 5. Wrote letter to Vice President Darling thanking him for support of Texas Tech Faculty Senate membership in Conference of Faculty Governance Organizations.
- 6. Notified Vice President Darling of the election of Faculty Senate officers for 1983-84 and sent letters of congratulations to the officers.
- 7. Notified appropriate administrative officers of various nominations for Councils and Committees approved by the Senate.
- 8. Notified new officers of the upcoming Conference of Faculty Governance Organizations meeting April 21-22 in San Angelo.

From the Academic Council Minutes - March 1, 1983

- 1. Announcements
 - a. The appointment of Dr. Clyde Jones as Director of the Museum was announced.
 - b. A memorandum regarding faculty development assignments was distributed. The memorandum invited additional faculty development leave proposals on the possibility that funding for faculty development assignments may be passed in the current legislature.

c. Information was distributed regarding review of prospective faculty, which essentially places the responsibility for the review for those with appropriate experience and terminal degrees in the office of the deans. An additional element of the operating policy draft was a continued emphasis upon the acquisition of qualified minority and protected group candidates for the faculty. Page 2.

- d. Dr. Darling and Dr. Bradford are now establishing meeting times to visit with faculties and Dr. Darling, Dr. Jones and Dr. Payne will also be setting discussion meeting with faculties.
- 2. There was a lengthy discussion regarding the establishment of academic standards for admission and continuance in the university. Deans requested additional information regarding the impact of change in entrance scores and suggested some rewording of the probation and suspension regulations. This item is to be discussed at a subsequent Council meeting.
- 3. Dr. Ramsey distributed information about a proposal regarding computer literacy and asked for comments. Deans were asked to respond to the idea that at least one semester credit hour of content would be devoted in every degree program to involvement with the computer. Deans will be asked for a decision at the next Council meeting

Agenda item V.

Emeritus Appointments

It has dome to the attention of the Faculty Senate that since the Board of Regents policy concerning emeritus appointments was published in the 1976-1977 Faculty Handbook that policy has been changed, apparently without notice to, or the advice of, the Faculty Senate. Perhaps the change was inadvertent but in any event its literal effect is to make an emeritus appointment for a faculty person who has completed service of ten years or more at Tech discretionary without providing any standard for exercise of that discretion. Absent any apparent rationale for the change and given the absence of standards for discretionary appointments, the former policy of automatic qualification on completion of the requisite years of service should be reinstated. Therefore.

BE IT RESOLVED THAT:

The Faculty Senate recommends to the President that the Board of Regents policy concerning emeritus appointments at Texas Tech University be amended by substituting the word "shall" for the as officient underviewith word "may" in the second sentence and third sentences.

Former Policy on Emeritus Appointments from Faculty Handbook 1976-77:

Emeritus Appointments

The Board of Regents has established the following policy with respect to emeritus appointments.

The title "emeritus" shall be conferred as a recognition for long and faithful service or for very distinguished service to the institution.

Members of the faculty with rank of professor or associate professor shall at retirement be given emeritus appointments, provided they shall have completed at least ten years of service at Texas Tech University or shall have been recommended on the basis of "very distinguished service." In the latter event, the advice of the Executive Committee of the Faculty Council shall be sought by the President.

Administrative officers in major positions shall at the time of retirement from administrative duties be considered for emeritus appointments.

Emeritus appointment shall be strictly honorary and without stipend.

Each such appointment shall be subject to approval by the Board of Regents upon recommendation by the President.

Present Policy on Emeritus Appointments proposed to be published in the Revised Faculty Handbook:

Emeritus Appointments

The Board of Regents has established the following policy with respect to emeritus appointments. The title "Emeritus" may be conferred as a recognition for long and faithful service, or for very distinguished service to the institution. Members of the faculty with rank of Professor or Associate Professor at retirement may be given emeritus appointments, provided they have completed at least ten years of service at Texas Tech University, or have been recommended on the basis of "very distinguished service." If the emeritus status is proposed on the basis of very distinguished service, the advice of the Faculty Senate shall be sought by the President. Administrative officers in major positions at the time of retirement from administrative duties may be considered for emeritus appointments. Emeritus appointments are strictly honorary and without stipend. Each such appointment shall be subject to approval by the Board of Regents upon recommendation by the President.
