##### **Withdrawal dates for LAW Summer I 2018:**

May 28 or earlier -100% refund  
May 29 through May 31 - 80% refund  
June 1 through June 5 - 50% refund  
June 6 through end of session- No refund

##### **Withdrawal dates for LAW Summer II 2018:**

July 8 or earlier -100% refund  
July 9 through July 11 - 80% refund  
July 12 through July 16 - 50% refund  
July 17 through end of session- No refund

##### **Withdrawal dates for LAW Full Summer 2018:**

May 28 or earlier -100% refund  
May 29 through June 4 - 80% refund  
June 5 through June 11 - 70% refund  
June 12 through June 18 – 50% refund  
June 19 through June 25 – 25% refund  
June 26 through end of session- No refund
