Agribusiness Finance (AAEC 3302): Undergraduate course introducing the basic principles of finance, emphasizing the mathematics of finance, credit, and financial analysis.

Farm and Ranch Business Management (AAEC 3304): Undergraduate course covering the organization and management of individual small businesses including farms, ranches, input suppliers, and commodity processors.

Texas State University (August 2013 to August 2014)

Introduction to Agricultural Economics (AG 2383): Undergraduate course covering the role of agriculture in the general economy, the study of basic economic concepts with application to the agricultural firm, structure and operation of marketing systems, and the functional and institutional aspects of agricultural finance.

Computer Applications in Agriculture (AG 2390): Undergraduate course introducing basic computer technology used in the management of agricultural businesses, specifically the Microsoft Office suite of programs. Students gain experience using Microsoft Word, Microsoft PowerPoint, Microsoft Access, and Microsoft Excel.

TEACHING RESPONSIBILITIES (CONTINUED)

Texas State University (Continued)

Farm Management (AG 3317): Undergraduate course that introduces tools and techniques essential to the study of farm organization and decision-making. Topics covered include economic principles related to production agriculture, enterprise budgeting, partial budgeting, linear programming and whole-farm planning, cash flow budgeting, and risk, personnel, land, and machinery management.

Agricultural Finance (AG 4380): Undergraduate course introducing finance issues faced by agribusiness managers. Topics covered include financial planning and control, financial statements, financial analysis, capital budgeting, liquidity and risk management, and financial markets.

Agricultural Policy (AG 4381): Undergraduate course that identifies and analyzes governmental programs and policies affecting agricultural production and marketing. Economic evaluation of alternative policies and applications for producers, consumers, and agribusinesses is considered.

Virginia Tech (August 2012 to August 2013)

Personal Financial Planning (AAEC 2104): Undergraduate course introducing basic financial planning concepts and tools. Topics covered include planning and budgeting, income taxes, time value of money, cash and credit management, loans, personal insurance needs, investments, retirement planning, and estate planning.

Agricultural Financial Management (AAEC 4424): Undergraduate course covering topics related to the financial management of various agricultural businesses. Subject matter covered includes production economics concepts, various budgeting techniques, credit, loans, financial statements and financial analysis, and investment analysis.

Agricultural Management and Problem Solving (AAEC 4404): Undergraduate capstone course for agribusiness management students. Economic concepts, principles, and decision-making tools are applied to a real life family farming business. Students create a formal business plan which addresses issues including strategic planning, marketing, budgeting and financial management, personnel management, and farm business transition planning.

Farm and Ranch Management Lab (AAEC 3304): Undergraduate course consisting of three hours of lab twice per week. Lab exercises include enterprise budgeting, linear programming, cash flow budgeting, personnel management, investment analysis, risk management, business organization, land management, and machinery management.
