## A. Vice Provost and Associate Vice Provost, Office of International Affairs (2014 to 2022)

Responsible for the oversight of all functions of the Office of International Affairs, including International Enrollment Development (international recruitment, international undergraduate admissions, sponsored students), Study Abroad, International Student and Scholar Services, International Student Life, International Research and Development (research collaborations, grants administration, international partnerships, and export control administration), International Relations (international alumni, international art and culture, fundraising), K-12 Global Education Outreach, and OIA Operations (finances, facilities, and Passport office), as well as the academic center in Seville, Spain. Was also responsible for the supervision of the Center for Arid and Semi-Arid Land Studies and the Center for Global Communication.

- Texas Tech University was featured for the first time in 2018 in the QS World University rankings at 701-750; and maintained the same ranking in 2019.
- Development and implementation of the 2015-2020 International Strategic Plan and annual assessment protocol.
- Creation of the International Research and Development (IRD) division in OIA to assist faculty with external funding for international research and development. Since 2014, IRD has successfully helped faculty develop over \$87M in international research & development grant proposals as of May 1, 2021.
- Establishment of Study Abroad Program Development Seed Grants Program, International Research/Development Seed Grants Program, and International Travel Fund for faculty.
- Development of several successful international collaborations, including: Brazil Scientific Mobility Program; FAPESP x TTU Joint Research Initiative; BHEARD Fellowship Program; and BORLAUG Fellowship Program.

- Continuing strong enrollment of international students After experiencing a 55.2% increase in undergraduate international students and 30.7% increase in overall international students between Fall 2013 and Fall 2018, we saw a small decrease in international student enrollment due to factors beyond our control. However, our decline in international student enrollment was smaller than the national average.
- Record study abroad opportunities for Texas Tech students In the 2018-2019 academic year, OIA's Study Abroad unit helped organize over 150 international education programs for over 1,384 students (a 65% increase in the last 5 years). All study abroad programs for Summer 2020, Fall 2020, and Spring 2021 have been cancelled due to the COVID-19 outbreak.
- Recipient of the Senator Paul Simon Spotlight Award for K-12 Global Education Outreach programming in 2016.
- Recipient of the Senator Paul Simon Comprehensive Internationalization Award in 2018.
- Overall coordination of a university-wide effort to open our first international degreeawarding campus in Costa Rica. The first cohort of students began classes in five degree programs in Fall 2018.

## B. Coordinator and Acting Dean, Texas Tech University – Costa Rica (2014 to 2019)
