What should I wear?

Business professional is recommended (but not required) for a good first impression to the law school representatives. The Career Center has a clothes closet, and they also hold events for purchasing professional clothes on sale. Professional Conversation:

When speaking to the representatives remember that not only do you represent yourself but also TTU. Be respectful and professional even if you don't plan to attend the school they represent.

If you are interested in attending a specific school, it may help to research them before speaking with a representative. Treat this like a mini job interview. Come ready with questions about the programs they offer, or the city their school is located in. But no need to bring a resume. You will submit one later as part of your application.

You will likely fill out an information card for schools you are interested in. Write your information legibly and use your TTU or professional-sounding personal email account. Be sure to check your spam folders for communication from law schools.

Some questions to ask the representatives:

- Do you have an application fee? If so, do you offer application or CAS fee waivers?
- Does your school have "early action" or "early decision"?
- What are your median GPA and LSAT scores? How many times in your opinion should I take the LSAT?
- Do you offer merit or need-based scholarships or grants? What criteria do you use?
- What is the estimated cost of attendance at your school, and do you anticipate a tuition increase?
- What are your bar passage rates? What kinds of jobs do your graduates take after law school?
- What career services are offered to students and graduates? How many students find summer or part-time employment through your school?

- What percentage of graduates practice in the region around your school? How do you help students find jobs outside the region?
- What kinds of extracurriculars/organizations do you offer?
- What kind of mental health resources are available to your law students?
- What other programs and services are available to law students? (Academic success program, tutoring, health and wellness programs, financial aid services, in-house IT services, meal plans, etc.)
- Do you have a mentoring program for 1Ls?
- What journals, clinics, and advocacy opportunities do you offer?
- What do students like most about your school? Least?
- What opportunities are available for prospective or admitted students to visit your campus?
