4. The THECB approved the appeal to include PSS 2310 as part of the creative arts core curriculum for 2017-2018.
5. Documentation on the requirements for certificates was discussed. More clarification about why certificates cannot be awarded without a degree and if current students will be grandfathered was requested. Departments were also asked to review current requirements for certificates and notify the Registrar's Office if there are any updates.
6. An announcement was made that students will no longer receive credit for ENGL 1301 and 1302 based on SAT/ACT test scores. This will be effective Fall 2018.
