### **AREAS OF RESEARCH:**

---

*My overarching area of research is identifying systemic factors that impact substance use and other negative outcomes. This includes examining how family and other relationships influence substance use across the lifespan, identifying the mechanisms responsible for substance use differences, and exploring the interaction of social location with substance use outcomes. I have a particular interest in identifying how relationships affect emotional processes involved in substance use development, and in bringing attention to the varying experiences of diverse communities. Current projects are focusing on the interaction of biological and environmental influences in predicting substance use outcomes, and testing whether changes in language around addiction impact how others view and may respond to an "addict."*
