Creating a USCIS Account

To complete an online application for OPT, you must have (or create) an online USCIS account at:

I-765, Application For Employment Authorization

Certain foreign nationals who are in the United States may file Form I-765, Application for Employment Authorization, to request employment authorization and an Employment Authorization Document (EAD). Other foreign nationals whose immigration status authorizes them to work in the United States without restrictions may also use Form I-765 to apply to U.S. Citizenship and Immigration Services (USCIS) for an EAD that shows such authorization.

Foreign nationals may also apply for a Social Security number and card on Form I-765.

If you are a lawful permanent resident, a conditional permanent resident, or a nonimmigrant only authorized for employment with a specific employer under 8 CFR 274a.12(b), do **not** use Form I-765.

Submitting your application online is the same as mailing in a completed paper form. They both gather the same information.

You should answer all questions in the Getting Started section first so we can best customize the rest of your online form experience.

Servide as many responses as you can

You should provide as many responses as you can. Incomplete fields or sections and missing information can slow down the process after you submit your form.

Selecting your eligibility category



Select "c(3)(C) STEM Extension."

- STEM OPT is **only** for students with degrees in Science, Technology, Engineering and Math (<u>see STEM</u> <u>degree list here</u>).
- If you are eligible for a STEM OPT extension, you can only apply 90 days before your OPT EAD end date.

Employer E-Verify Information

Your STEM work must be **related to the degree** that you completed.

You may only be employed **by an E-Verify employer** on STEM OPT. Only your employer knows if they are everified or not.

Premium Processing

Would you like to request Premium Processing Service?

Premium Processing Service guarantees that USCIS will take one of several possible actions (issue an approval notice, a denial notice, a notice of intent to deny, or a request for evidence or open an investigation for fraud or misrepresentation) on your Form I-765 within 30 days.

If you request premium processing, you will be asked to complete the Form I-907 after you sign your Form I-765. You will then be able to pay for and submit both forms at the same time.

Select "No" if you already have an SSN.

Additionally, if you'd like to receive your EAD card faster, you can apply for **Premium Processing** when (or after) you submit your application for an added fee. Premium Processing guarantees your application is processed within 30 calendar days, and the EAD will be sent about 2-3 weeks after that.

You can apply afterward for <u>Premium Processing here</u> by filling out the I-907 form.

After Submission



After submitting your application, please allow **2-4 months** to process, depending on the <u>time of submission</u> and if you selected premium processing (about 2 months max).

When you receive your new STEM OPT EAD card, <u>please send your DSO a copy of the</u> <u>front and back of the EAD!!</u>

Then you will be provided with **STEM OPT reporting requirements** that are *different* from your OPT reports and are critical to maintaining your F-1 visa status.
