Thursday, September 4, 2025.—The members of the Board of Regents of the Texas Tech University System convened in a special-called meeting by videoconference at 10:34 am on Thursday, September 4, 2025. The presiding regent (Chairman Campbell) location was at Double Eagle Energy, 3724 Hulen Street, Conference Room 1A, Fort Worth, TX 76107. The videoconference and administration/staff location was at the Board of Regents Committee Room (106), First Floor, System Administration Building, 1508 Knoxville Avenue, Lubbock, Texas. 
