2024 Annual Report for the Department of Kinesiology and Sport Management

- ➤ KSM welcomed three new faculty, Dr. Jessica Brougham and Jennifer Corder, with an approved delay until January 2025 for Dr. Sarah Brown.
- ➤ Including these new faculty in the fall semester of 2024, the faculty by rank included 3 professors, 9 associate professors, 11 assistant professors, 5 assistant professors of practice, 3 senior lecturers, and 4 part-time instructors. KSM's staff included a Unit Manager, Lead Administrator for graduate programs and management of start-ups and grants, a receptionist/business assistant, four undergraduate advisers, and a half-time Instructional Support Technician I.
- ➤ In the fall of 2024, KSM faculty taught 1245 KIN majors in the B.S. in Kinesiology and 423 majors in the B.S. in Sport Management.
- The department offers five minors: Athletic Coaching (n=297), Health (n=23), Kinesiology (n=152), Public Health (n=46), Sport Management (n=167), and Sports Medicine (n=165).
- ➤ In the fall semester, KSM had 134 graduate students, 32 in the M.S. in Kinesiology, 85 in the M.S. in Sport Management, (of these master's degree students, 18 were funded by the department to teach Personal Fitness and Wellness courses), and 17 students in the Ph.D. in Exercise Physiology, funded by the department.
- ➤ The department is the sole occupant and manages the Kinesiology and Sport Management Building with 31,483 square feet (including 10,308 square feet in 13 independent research and 4 shared research labs). KSM also uses classrooms and activity spaces in the Ewalt Student Recreation Center.

- > Dr. Aaron Arreola and Dr. Audra Day were promoted to Associate Professor of Practice with continuing appointment.
- > **Dr. Grant Tinsley** was named the Spring Semester Speaker for Texas Chapter of the American College of Sports Medicine Lecture Series.
- ➤ **Dr. Katie Brown** has received the 2024 Lori K. Miller Sport and Recreation Law Association Young Professional Award.
- ➤ Bailey Palmer was honored at a formal ceremony in April with the Professing Excellence Award. This award recognizes a faculty member's impact on the academic success of Texas Tech students living in the residence halls.
- ➤ **Dr. Marc Lochbaum** received a European Innovative Teaching Award in 2024 from the European Commission, International. The JoyMVPA project that he co-wrote for an Erasmus grant in 2019 received this award in the 7-year cycle as one of the best projects in the Innovative Teaching section.

SPARC's mission is to ignite the passion of excellent within sport management students by providing innovative resources and training and empowering them to reach their highest potential in the dynamic field of sport management.
- ➤ Hyoseon Kim in May, Katherine Dillon, Nigel Jiwan, Yejin Kang, and Madelin Siedler in August, and Mauricio Martinez in December graduated. These six brought the total number of graduates with a Ph.D. in Exercise Physiology to 13.

- > The department purchased and installed new displays, to replace screens, in its six classrooms.
- The department began a new 30-credit hour Master of Science in Sport Management with face-to-face and online cohorts, while phasing out the 36-hour program with largest number of students (i.e., 85) ever in this program.
- ➤ The department completed research-related renovations in 109 and 103 of the Kinesiology and Sport Management Building.
- Five coordinators and a new Department Associate Chair were appointed or reappointed.
- New KSM Bylaws were developed (and approved by the faculty on January 13, 2025).
