Come visit and feel the energy, the warmth, and the unmistakable Texas Tech Law spirit that make this place feel like home.

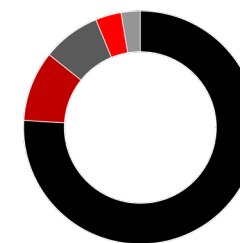
