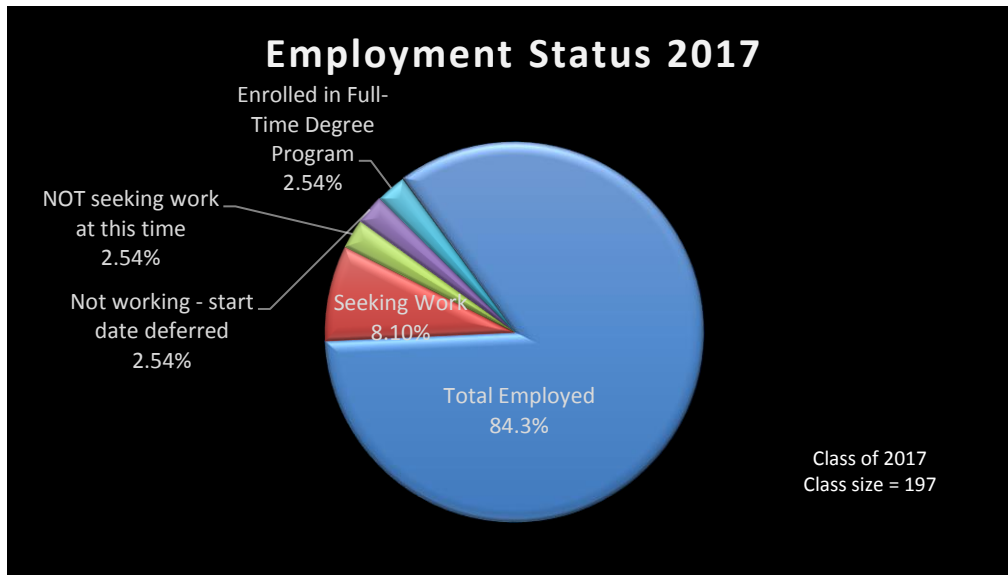

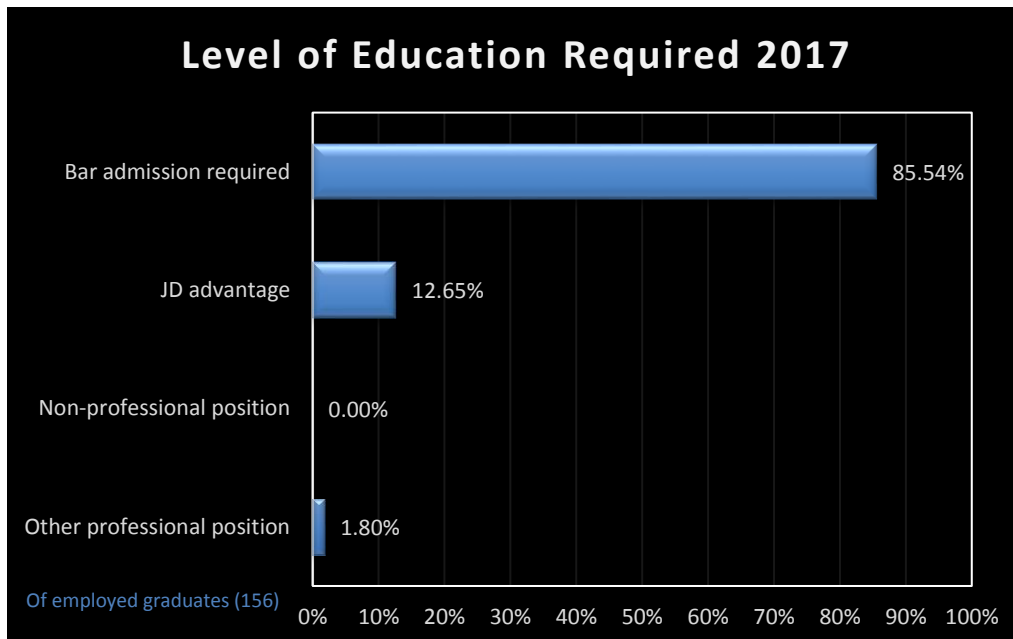

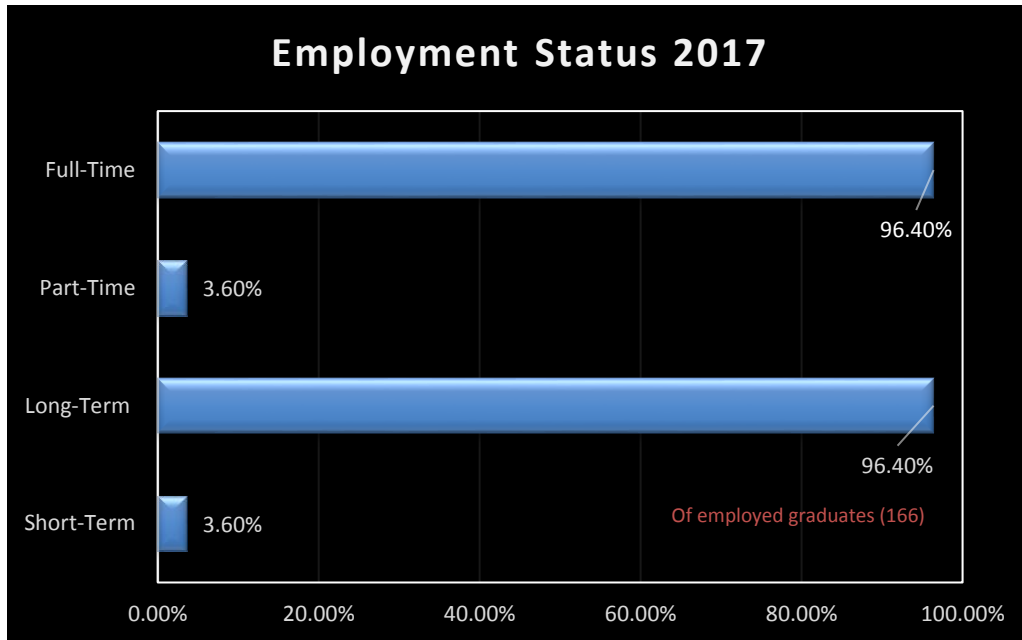
### Texas Tech Law Class of 2017 Employment Status ten months after graduation (as of March 15, 2018)



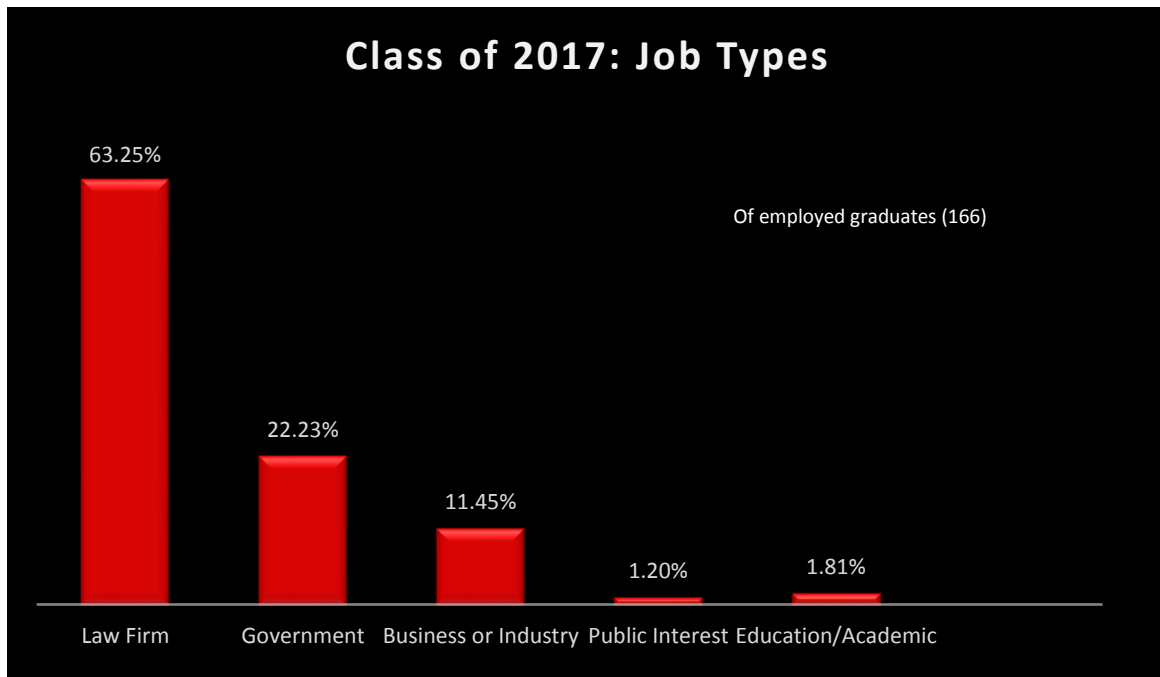
### Texas Tech Law Class of 2017 Employment by Education Required

## Texas Tech Law Class of 2017 Job Types



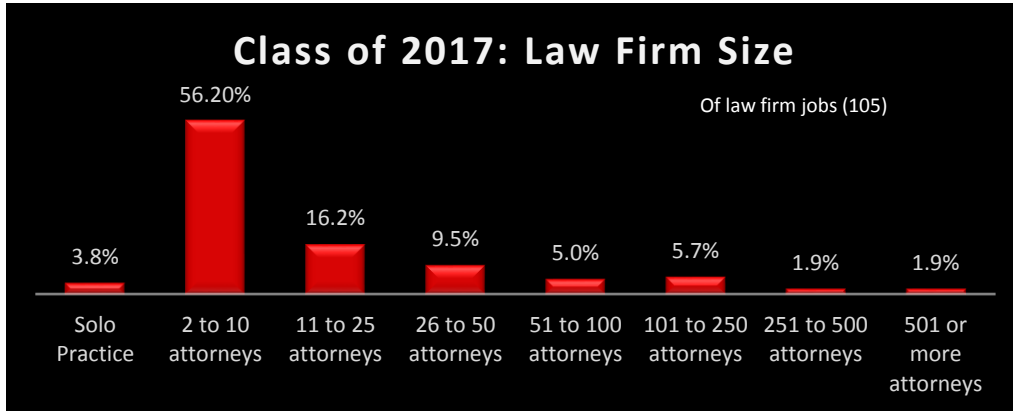

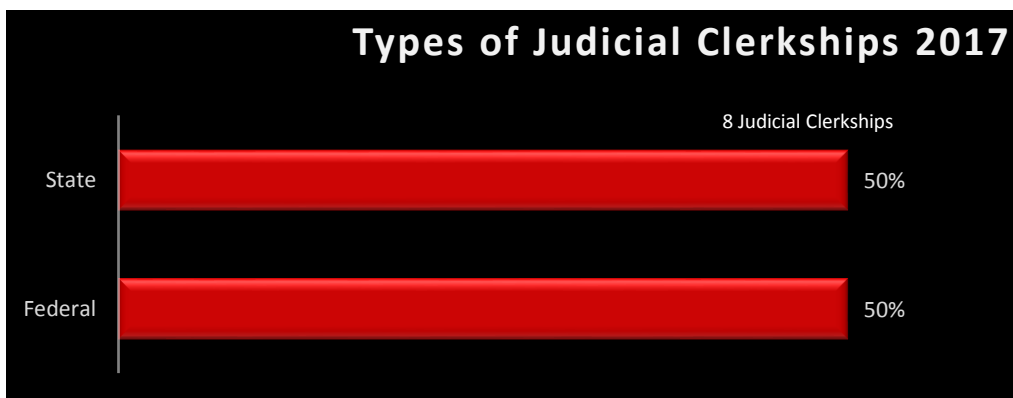

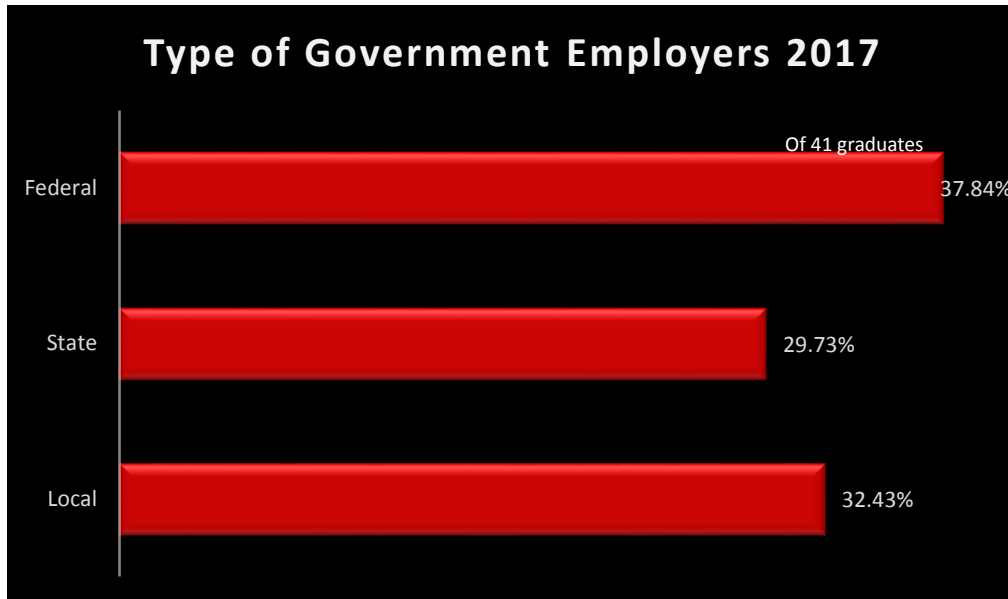

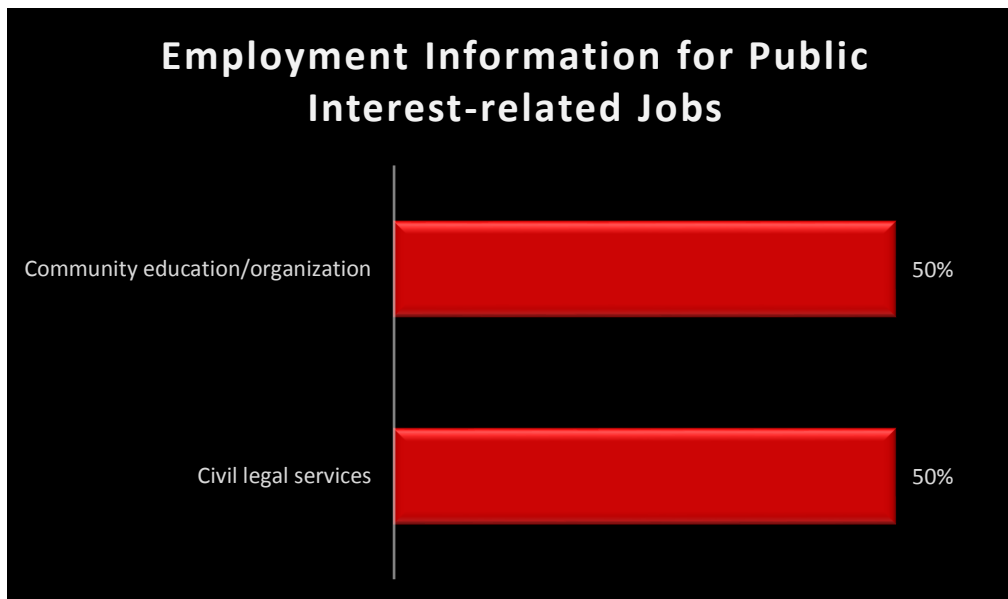
**Texas Tech Law Class of 2017 Employment Information for Government Employers (including judicial and military)**



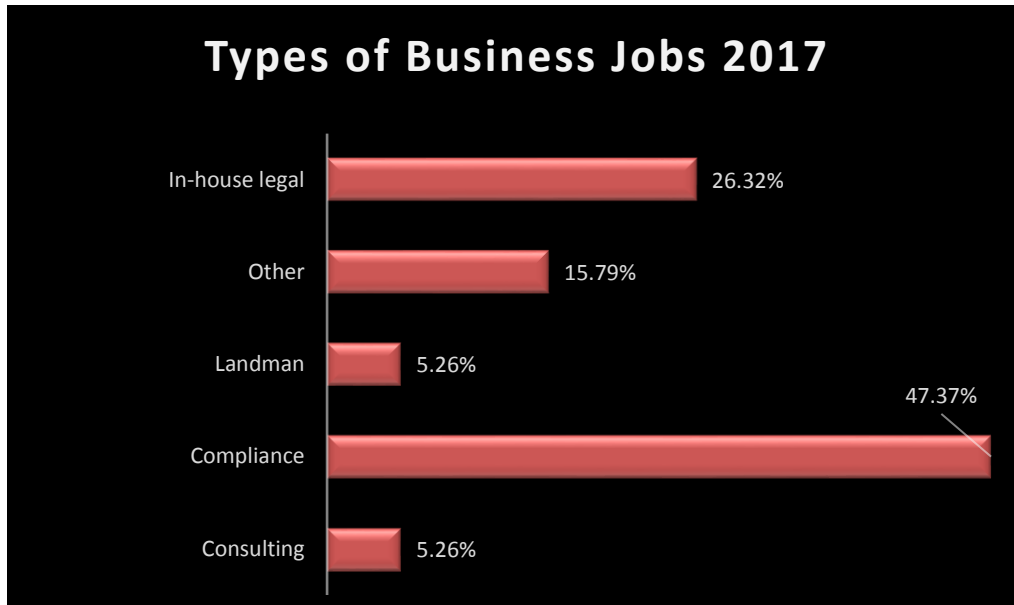
