## **Strategic Priorities:**

**Priority 1: Curate a reliable and robust collection designed to connect users to resources that support the interpretation and practice of law and the [Law School's mission](#).**

### **Priority 1 Goals:**

- Perform regular collection development of resources appropriate for a modern academic law library to support research, curricular, and Law School programmatic needs.
- Maximize collection resources through careful fiscal planning and management, vendor relations, cooperative agreements with library consortia, and various assessment methods for efficacy.
- Use the latest methods in metadata theory to improve the catalog and ensure access to law library resources through comprehensive description and organization that facilitates discovery, access, and use of information.
- Develop methods for connecting users to library resources, including creating and curating essential guides for dissemination.
- Collect Law School work product and provide open access to materials on the institutional repository to share ideas and advance knowledge.
- Implement sustainable and innovative practices to maintain and preserve the Law Library's collection in accordance with the collection development policy.

**Priority 2: Create a comprehensive legal research curriculum that anticipates the changing demands of the legal profession and ensures graduates are practice-ready with the ability to efficiently retrieve, evaluate, organize, and analyze information into useful knowledge.**

### **Priority 2 Goals:**

- Use evidence-based design to create and assess experiential instruction that develops research retrieval, organization, and analysis skills while promoting information ethics.
- Incorporate pedagogical best practices into all Law Library instruction.
- Partner with the Legal Practice Program to provide a consistent foundational legal research curriculum for the 1L experience.
- Provide advanced research instruction in the upper-level curriculum.
- Support and further build on the Law School's legal research student learning outcomes and assessment plan.
- Collaborate with faculty to provide "across the curriculum" legal research instruction opportunities.

- Assess gaps in curricular support, including legal technology, to develop additional learning opportunities.

**Priority 3: Provide reliable services to support and engage Law Library users and enhance relationships to ensure needs are met.**

**Priority 3 Goals:**

- Perform regular assessment of user services and programming to meet the evolving needs of users.
- Maintain robust support for faculty research and dissemination of scholarship.
- Maximize student use of Law Library resources through creative student services programming.
- Provide consistent reference and circulation services that are highly visible and meet user needs.
- Perform outreach and promote use of Law Library resources and programs, including the collection, institutional repository, research guides, inter-library loan, and other Law Library resources.
- Explore and embrace support and services for alumni and the public.

**Priority 4: Cultivate space for users to collaborate and engage with the law and foster an environment that encourages intellectual curiosity, respect, and well-being.**

**Priority 4 Goals:**

- Provide an inclusive environment for all Law Library users.
- Promote quiet study, collaborative learning, and access to the Law Library collection.
- Further develop and maintain comfortable and inviting spaces that promote user engagement.
- Proactively apply sustainable best practices and decision making in the Law Library space.
- Collaborate with various stakeholders to effectively use the Law Library space in accordance with the needs of the Law School Community.

**Priority 5: Intentionally pursue Law Library best practices and professional development to implement improved methods and services.**

**Priority 5 Goals:**

- Create a work environment that encourages compassion, creativity, forward-thinking, safety, and an open dialogue without obstacles to innovation.

- Support and value Law Library faculty and staff as experts who exercise sound professional judgment and seek professional development opportunities in areas of responsibility to advance the Law Library.
