Apply to be a 1L Doctrinal Tutor!

What is a Doctrinal Tutor & What are Their Responsibilities?

Tutors are leaders on campus who provide academic support and mentorship to first-year law students tied to the 1L doctrinal courses. Tutors are generally expected to hold weekly tutoring sessions at the times scheduled by professors and the law school, attend regularly scheduled class sessions for the course they are tutoring, hold office hours twice a week, and answer student questions, as necessary, outside of class.

The average workload is approximately 10-12 hours per week; however, the workload may not be evenly distributed throughout the semester (i.e., things may be slow at the beginning of the semester and pick up closer to final exams).

Other duties and responsibilities may vary from professor to professor and course to course.

What are the Basic Qualifications to be a Tutor?

Generally, a tutor should:

- Be a second- or third-year student during the 2024-2025 academic year;
- Have a B or better in the course(s) for which they have applied to tutor;
- Have a cumulative 3.0 or higher GPA for the semester in which they have applied;
- Have a cumulative 3.0 or higher GPA for the semester during which they tutor;
- Not have a dating or close personal relationship(s) with any student in the section that they wish to tutor; and
- Not also be a Legal Practice Teaching Fellow or have other employment at Texas Tech University School of Law or Texas Tech University during the semester that they intend to tutor.

How Many Tutors will be Selected?

Professors who teach first-year courses will typically select one or two tutors for each section of the courses they teach.

Fall 2024

Some professors have already selected their tutors for the Fall 2024 semester. Applications submitted through this <u>form</u> will be sorted and forwarded for consideration by Professors Bryan Camp (Civil Procedure), Richard Murphy (Civil Procedure), John Watts (Civil Procedure), Brian Shannon (Contracts), Bill Casto (Contracts), and Barbara Lauriat (Torts), as well as the forthcoming Contracts professor.

How Long is the Tutoring Term?

The term for an appointment as a tutor is for the full fall or spring semester.

What is the Compensation for Serving as a Tutor?

Each section of a course has a stipend budget of \$1,250. Whether a tutor receives part, or all the section budget depends on whether that professor hires multiple tutors, among other considerations.

Is There Any Other Information I Should Know About Being a Tutor?

Tutors are evaluated early-to-middle of the semester to ensure that they are providing appropriate and beneficial sessions for their students. Tutors are also evaluated at the end of the semester for similar purposes, as well as for programmatic quality and future tutoring appointments.

How Do I Apply to be a Tutor?
