#### Outcome 1

The Office of Planning and Assessment will contribute to Texas Tech University's ongoing compliance with all external accrediting agencies and State of Texas mandates.

### Graduate School Expansion Project

After more than a year of meetings and planning, OPA, Application Development and Support, and The Graduate School have developed a way to import graduate students to the Faculty Success (formerly Digital Measures) platform. This will serve the dual role of providing a database to track and report student scholarly activity while also providing space for student evaluation where needed.

OPA is focusing primarily on PHD students in various departments who have already been a part of the planning of this project. OPA and TGS will continue to monitor the import as new students are registered and as existing students begin to utilize the new screens in Faculty Success.

This method of beginning with Doctoral students is a great approach as it allows us to test this import on a population that may be involved in both aspects, faculty and student, at TTU. Many Doctorates are also TA or GPTI and may not even need an account to be created. This gives us three main populations: students, student assistants, and faculty who are also enrolled as students. Through these tests, we have determined failsafes and means to improve the system's reporting options.

Graduate Students will be able to use FS as soon as their accounts have been created. The primary difference between students and faculty is the new section entitled Graduate Students. This stores the Individual Development Plan, and we have developed a report for those monitoring student activity.

The deadline for this Review was this week, March 31<sup>st</sup>. There was positive buy-in from chairs about this process! In the future, OPA needs to be clearer distinguishing the purposes of the College-Level Reviews versus the university-level Program Assessment Reviews. Specifically, the PAR process ensures compliance with SACSCOC; Whereas, the College-Level Reviews emphasizes the peer feedback from colleagues in similar academic fields.
