January 2021 HB 2504 Report

OPA has prepared documentation to be sent on January 1st to Governor Abbott regarding House Bill 2504 compliance. We have also prepared a supplemental one-page report to explain Texas Tech's syllabus compliance from Fall 2019 through Fall 2020. This report will be shared with Dr. James closer to the deadline. An excerpt of the draft report is italicized below.

We begin each term by triggering an automated process that creates and imports course information for faculty. This allows for quick upload using Digital Measures, which outputs to our Public Access to Course Information website. Communication regarding HB 2504 from the managing office of OPA occurs in faculty orientation and via email to departments and new faculty prior to the start of each term. Our aim is to remind department chairs and deans of the requirements of HB 2504 prior to the start of courses and communicate through the 7th class day deadline. During this time, compliance lists and names of those with outstanding requirements are sent to Department Chairs and, after some time for response and correction, the updated report is forwarded to Deans.

GPI Launch

All first-year and senior students have been invited to participate in the final administration of the Global Perspective Inventory (GPI). This survey administration commenced on October 13th, 2020 and is planned to close on

October 31st, 2020. The results from this survey are used as evidence for the Quality Enhancement Plan. Below is an example of the email sent to our students.

- Hall and Hughes have been collaborating closely on a document pertaining to 6.2.b. This document is the primary piece of evidence for compliance, and will be shared with Dr. Stewart next week.

- Callison and Hall have been preparing PDF's to use as accompanying evidence for 10.2. These documents have been uploaded into the office's shared drive.
- Standard 10.6 is currently in the process of iWebfolio uploading. We expect this to be complete by the end of next week.
- Shatley is preparing evidence over 10.9. The narrative for 10.9 was approved by all committee members on Monday, October 12.
