#### Dr. Marcus Tanner

#### University Studies

Dr. Tanner's application focused on the challenges of assessing an interdisciplinary degree program. Specifically, Dr. Tanner discussed how the assessment plan for University Studies is "relatively new" and faculty need to be "familiar with the plan, the methods for collecting assessment data, and review individual course SLOs for alignment." Dr. Tanner's AIG funds will be allocated toward faculty engagement.

#### Spanish


Dr. Vasseur's application explained the need for TTU Spanish majors and minors to use "Spanish post-graduation in an increasingly globalized world." Dr. Vasseur highlighted how AIG funds will be used to assess students' language proficiency skills by funding a certified American Council on the Teaching of Foreign Languages (ACTFL) Oral Proficiency Interview (OPI) tester. Having a local tester will allow students to demonstrate that they have "certified" language skills.

# **NSSE Pulse Survey Administration**

The NSSE Pulse was open from October 16th through November 6<sup>th</sup>. The Office of Planning and Assessment is pleased to report there were more than 1,100 responses to this survey. OPA is anxious to review feedback from students, and we are hopeful these data will shed light into the needs and expectations of students during this unprecedented time. # **GPI Survey**

The Global Perspectives Inventory was open from October 5<sup>th</sup> through October 31<sup>st</sup>. The GPI team from Iowa State will be working on generating a final report of the data within the next few days. OPA expects to receive data from the GPI next week and will provide the report to Dr. Paul Pare for use in the QEP Impact Report.

These changes are part of a larger website update which will see new, more directed information for new faculty, existing faculty, or administrative employees. Our redesign will make the website easier to navigate and locate information based on rank or teaching experience, so that new faculty are not seeing how to run administrative reports, while administrators are not seeing how to enter CV information. Overall, we believe this will make information dissemination more effective.

# Fifth Year Report Update

### <u>Update on SACSCOC Fifth Year Report Activity Week of November 9<sup>th</sup>.</u>

- Hughes received the final faculty data needed for 6.2.b. Hughes is currently in the process of assigning BA faculty to their respective degree programs, as some faculty teach in more than one degree program and will therefore be double-counted.
- Hughes and Shatley completed the final draft for 10.9, which was disseminated to Dr.
  James on Friday, November 6. Shatley will continue to gather and refine the evidence
  files for 10.9. For example, we will be seeking transcript credit evidence and further
  evidence on how academic agreements are regularly evaluated.
- Hughes received the final admissions response on 11/5/20. Hansard will be sending a jump
  drive to the OPA office next week with all evidence. OPA will begin formatting this response in
  preparation to send to Dr. James.
- Spradlin continues to gather critical evidence for 8.1. This week, she received certification information from the Whitacre College of Engineering.



The Office of Planning and Assessment will continually monitor the university's compliance with laws, policy statements, and policies deriving from the State of Texas, THECB, and SACSCOC.
