FOOD TRUCK SERVICES TERMS AND CONDITIONS

These Terms and Conditions, along with the Food Truck Services Application (the Application") and any linked terms included therein, shall make up the "Agreement". "TTU" shall refer to Texas Tech University. "Vendor" shall refer to the Food Truck Services vendor as stated in the Application. Vendor and TTU may be referred to herein individually as a "Party" and collectively as "Parties."

1. Vendor's Food Truck Service ("Services") Requirements

1.1 Services.

- **1.1.1** <u>Location</u>.
 - 1.1.1.1 The Services may be conducted on any TTU campus in a space and time assigned by TTU prior to an event ("Event"). The Vendor shall only provide Services in the assigned space and time for the Event. Services are limited to any TTU campus located across the State of Texas.
 - **1.1.1.2** TTU will assign a specific placement location for the Vendor to provide Services (the "Space") prior to the performance of Services. The Space shall be assigned by the TTU Outdoor Events Coordinating Committee (the "Committee"). The Vendor is forbidden from providing any Services unless approved by the Committee and shall only provide Services on the date and the Space assigned by the Committee.
 - 1.1.1.2.1 TTU reserves the right to change the Space location in its sole discretion at any time as needed.
 - **1.1.1.3** Vendor shall ensure that all employees or subcontractors of the Vendor occupy only the assigned Space during the performance of Services and during the time and date allocated by TTU.
 - **1.1.1.4** Vendor shall not bring portable restrooms or dumpsters onto the campus.
 - **1.1.1.5** Electricity, generators, water, ice, tables, chairs, barricades, coolers, and trash disposal will not be available or provided by TTU. The Vendor will not have access to any TTU facilities.
 - **1.1.1.6** Vendor shall not park vehicles, other than the food truck in the Space for safety considerations. The Committee, along with the TTU Traffic and Parking Services department, will coordinate parking arrangements with Vendor if needed.
 - 1.1.1.6.1 Vehicles and trailers belonging to Vendor or employees of Contractor that are driven on TTU campus in the performance of Services must have Vendor's name prominently displayed. Magnetic signs are acceptable.
- **1.1.2** Space Set-Up and Tear Down.

- **1.1.2.1** Vendor is responsible for all set up, and tear down, and loading and unloading of equipment and supplies.
- **1.1.2.2** Vendor will coordinate with TTU prior to any setup due to other campus events, night classes, bus routes, and other considerations.
- **1.1.2.3** Vendor may begin set up no earlier than three (3) hours in advance of an Event.
- **1.1.2.4** Vendor shall not attach any equipment or signage to any TTU property, including trees, buildings, handrails, lampposts, etc. Vendor shall not display signs or advertising devices outside Space or beyond limits of Space as to interfere with any adjacent space.
- **1.1.2.5** Vendor shall not leave supplies, displays, signage, decorations, or equipment in any walkway, ingress, or egress but shall be confined to the Vendor's assigned Space.
- **1.1.2.6** Prior to staking anything into the ground, Vendor shall obtain prior approval from the Committee and have the location(s) checked for utility lines at least three (3) days before the Event by contacting TTU Operations Work Control at 806-742-4677 (742-4OPS). This is to protect the TTU Grounds and TTU Underground Utilities.
- **1.1.2.7** Vendor shall take all industry prudent precautions to protect existing TTU structures and property and to prevent damage to TTU buildings, building contents, land improvements, and landscaping. After Services have commenced, Vendor will be liable for any damage to any TTU property, grounds, and contents during the course of the Services.
- **1.1.2.8** Vendor shall place all trash and recycling in proper bins to be provided by and disposed of by Vendor off campus. Vendor shall not use TTU trash receptacles or dumpsters. Vendor shall properly dispose of all waste, including grease and other bi-products off the TTU campus. Vendor shall not dump any grease on the grounds.
- **1.1.2.9** Vendor shall remove all Vendor equipment and supplies, from the Space and the campus within two hours after the end of the Event.
- 1.1.3 Food and Beverage Requirements.
 - **1.1.3.1** Vendor shall not bring any glass containers into the Space or serve any food or beverages in glass containers.
 - **1.1.3.2** The Vendor are prohibited from serving or selling any alcoholic beverages.
 - **1.1.3.3** Pursuant to TTU's Pouring Rights Agreement currently in effect, only Coca-Cola branded beverage products are allowed on TTU campuses. A list of approved beverages is provided in Exhibit B. The Vendor shall not serve any beverages not included on the list, including non-branded and branded bottled water. Non-branded coffee and tea sold in non-branded cups is permitted. Non-bottled water may be served.

- 1.1.3.4 The Vendor is required to comply with <u>Texas Department of State Health Services Food</u> <u>Handler requirements</u> and <u>TTU Environmental Health and Safety ("EH&S") standards</u> and acquire a <u>Temporary Food Service Permit</u> for each Event, in addition to any city-required permits. TTU EH&S reserves the right to conduct an inspection at prior to Services being provided or at any time while Services are being provided.
- **1.1.3.5** The TTU Fire Marshall must inspect and approve Vendor's equipment prior to a Temporary Food Service Permit being issued. The TTU Fire Marshall reserves the right to conduct an inspection at any time.
- 1.1.4 <u>General Requirements</u>.
 - **1.1.4.1** Vendor shall ensure that its employees hold all necessary certifications, permits, licenses, etc. (ex. Texas driver license, City of Lubbock Food Permit) as required by TTU, the city in which Services are provided, and the State of Texas.
 - **1.1.4.2** Vendor's Services shall not sell or include any promotional materials containing references to or sell, distribute, or display alcohol, nicotine, tobacco, vapes, any illegal substances, explicit language, nudity, or incendiary devices. Vendor is limited to selling food and beverages. Vendor shall not sell anything containing TTU identity marks or insignia.
 - **1.1.4.3** Vendor shall comply with the <u>City of Lubbock's requirements</u> or the city in which Services are provided, regarding food trucks, including but not limited to the use of propane tanks.
 - **1.1.4.4** Vendor shall not play music at an excessively loud volume. Please see <u>TTU Operating</u> <u>Policy 61.02</u>.
 - **1.1.4.5** Vendor shall comply with all City of Lubbock (or the city in which Services are provided) and State of Texas sales tax regulations and collect any sales taxes required. TTU will not be liable for any taxes due to the State or city for Vendor's Services.
 - **1.1.4.6** Vendor will ensure that all its employees, subcontractors, agents, and affiliate personnel comply with all provisions of the Occupational Safety and Health Act ("OSHA"), which can be found at <u>https://www.osha.gov/sshdir/tx.html</u>, as well as all other federal, state, and local safety requirements, occupational health standards, environmental laws, and other applicable ordinances, rules, and regulations in the performance of the Services.
 - 1.1.4.7 Vendor's failure to comply with any requirements of this Agreement or any other requirement of TTU, including but not limited to the Committee, EH&S, TTU Operations Division, or the TTU Fire Marshall shall result in the immediate cancellation of the Event, termination of this Agreement, and Vendor's removal from the TTU campus, as well as removal from TTU's Approved Food Truck List, without a refund of any fees paid or without any further obligation from TTU involving anticipated profits.
 - 1.1.4.8 Vendor shall not bring animals other than registered service animals to the campus or Space.

- **1.1.4.9** TTU reserves the right to inspect Vendor's equipment and truck or trailer at any time. TTU also reserves the right to examine any of Vendor's pertinent books, documents, papers, systems, and/or other records involving Services related to the Agreement.
- 1.1.5 <u>Contacts</u>.
 - **1.1.5.1** Vendor shall maintain a representative that works directly with the TTU sponsoring department.
 - 1.1.5.2 Vendor shall keep at least one (1) attendant in its truck or trailer during Service hours. Failure to do so may result in removal of the truck or trailer from TTU property at Vendor's expense.
- **1.2 Not Exclusive**. This Agreement is not exclusive, and TTU may engage other Vendors or use its own employees to perform Services.
- **1.3 No Guarantee**. TTU does not guarantee minimum or maximum compensation, revenue, or requests for Services under this Agreement.

2. Financial Arrangement

- 2.1 Fees to TTU. Upon execution of this Agreement, Vendor shall pay TTU an annual fee of five hundred dollars (\$500.00) in exchange for being added to TTU's Approved Food Truck List. The online payment for the fee must accompany the application. Failure to pay and/or maintain the annual required fee will result in removal from TTU's Approved Food Truck List and termination of access to the TTU campus.
- 2.2 Vendor Acceptance of Payments. Vendor shall provide means to accept payments for Services. TTU will not assist with payment processes or provide cash/change. If Vendor accepts cash payments, it shall comply with the requirements of the Committee.
 - 2.2.1 Vendor shall comply with all prevailing credit card rules and regulations, including, but not limited to, Payment Card Industry Data Security Standards ("PCI DSS") and Payment Application Data Security Standard ("PA DSS"). Refer to PCI Security Standards Council at https://www.pcisecuritystandards.org/.
 - **2.2.1.1** Vendor shall provide current proof of PCI DSS compliance to TTU.
 - **2.2.1.2** Vendor shall provide its own PCI DSS/PA DSS-validated point-of-sale terminal(s) and connectivity for the terminal(s).

3. Termination

3.1 TTU may terminate this agreement and/or any planned Services or Events for any or no reason by giving Vendor immediate written notice. Upon termination of the Agreement by TTU, Vendor shall immediately vacate TTU property and shall not be entitled to a refund of any fees paid to TTU.

4. General

 4.1 Independent Contractor Status. Vendor agrees that it and its employees and agents have no employeremployee relationship with TTU. TTU will not be responsible for the Federal Insurance Contribution Act

TTU and Contractor ("FICA") payments, federal or state unemployment taxes, income tax withholding, Workers Compensation Insurance payments, or any other insurance payments, nor will TTU furnish any medical or retirement benefits, or any paid vacation or sick leave. Vendor is responsible for the conduct of business operations, including employee salaries, travel, etc. Vendor is an independent Vendor, and this Agreement does not form a joint venture or partnership.

- **4.2 Insurance Requirements**. Consistent with its status as an independent Vendor, Vendor will carry and cause its Subcontractors to carry at least the following insurance, with companies authorized to do business in Texas or eligible surplus lines insurers operating in accordance with the Texas Insurance Code. TTU in no way warrants that these limits are sufficient to protect Vendor from liabilities that might arise out of the performance of the Services. Vendor will assess its own risks and, if it deems appropriate or prudent, maintain higher limits or broader coverages. Vendor is not relieved of any liability or other obligations assumed by reason of its failure to obtain or maintain insurance in sufficient amounts, duration, or types. All policies will be written on a primary basis, non-contributory with any other insurance coverage or self-funded plans which TTU maintains.
 - **4.2.1** Vendor agrees to furnish insurance certificates reflecting the following coverage:

NOTE: An umbrella policy may be used to reach required limits.

- **4.2.2** Commercial General Liability ("CGL") must include coverage for liability arising from Goods or Services completed operations and liability assumed under an insured Agreement.
 - **4.2.2.1** If the CGL insurance has a general aggregate limit, then ISO endorsement CG 25 04 (03/97 Edition) or its equivalent must be added. The Designated Location(s) General Aggregate Limit must be maintained for the duration of the Agreement, and the limit must be twice the minimum required occurrence limit.
 - **4.2.2.2** Vendor will name TTU and its Board of Regents, officers, employees, agents, and volunteers as Additional Insureds on ISO endorsement CG 20 26 or its equivalent. The policy shall include ISO endorsement CG 20 01 04 13.
 - **4.2.2.3** The CGL policy shall contain no endorsements or modification limiting the scope of coverage for liability assumed under an agreement or liability arising from pollution.

- **4.2.3** <u>Additional Insured, Subrogation</u>. All policies must include a waiver of subrogation favoring TTU. With the exception of the Workers' Compensation and Crime policies, TTU must be an additional insured on all policies.
- **4.2.4** <u>Certificates of Coverage</u>. Prior to Vendor providing any Services under this Agreement and at least thirty (30) days prior to the commencement of any renewal term of the Agreement, or upon renewal of the policies, Vendor shall furnish Procurement Services with certificates of insurance in a form acceptable to TTU, certifying that Vendor carries the required insurance policies and coverage. The certificates shall be sent to Procurement Services at <u>procurement.insurance@ttu.edu</u>. Failure of TTU to request such certificates does not eliminate the requirement for Vendor to maintain the required coverage.
- **4.2.5** <u>Notification of Cancellation</u>. Vendor will endeavor to notify Procurement Services thirty (30) days before any material change or cancellation of any insurance policy. In the event Vendor receives notice of modification or cancellation of any of the policies required under any Agreement, then prior to the effective date of modification or cancellation of the policy, Vendor will obtain a policy of insurance affording the required coverage from an insurance carrier acceptable to TTU. If Vendor fails to obtain such an insurance policy, TTU may immediately terminate the Agreement after providing Vendor with notice of such termination.
- **4.3 Publicity and Marks**. Vendor agrees that it will not publicize this Agreement or disclose, confirm, or deny any details of this Agreement to third parties. The Vendor shall not use TTU's name or protected identity marks, including but not limited to logos, seals, and insignia.
- **4.4** Force Majeure. "Event of Force Majeure" means an event beyond the control of Vendor or TTU which prevents or makes a Party's compliance with any of its obligations under the Agreement illegal or impracticable, including but not limited to: act of God (including, without limitation, fire, explosion, earthquake, tornado, drought, and flood); war, act or threats of terrorism, hostilities (whether or not war be declared), invasion, act of enemies, mobilization, requisition, or embargo; rebellion, insurrection, military or usurped power, or civil war; contamination or destruction from any nuclear, chemical, or biological event; riot, commotion, strikes, go slows, lock outs, or disorder; epidemic, pandemic, viral outbreak, or health crisis; or directive of governmental authority. No Party will be considered in breach of the Agreement to the extent that performance of their respective obligations is prevented or made illegal or impracticable by an Event of Force Majeure that arises during the term (or after execution of the Agreement but prior to the beginning of the term).
- **4.5 Emergency Health and Safety Procedures.** In the event of pandemic, epidemic, viral outbreak, health crisis, or other emergency ("Emergency"), TTU may, at its sole discretion, implement new or modified health and safety procedures in order to protect the health and safety of the TTU community. In the event of Emergency, Vendor agrees to adhere to all such procedures and related directives from TTU when entering onto and performing Services on TTU's campus.
- **4.6 Texas Family Code Child Support Certification**. Pursuant to Texas Family Code §231.006, Vendor certifies that it is not ineligible to receive this Agreement and acknowledges that the Agreement may be terminated if this certification is inaccurate.
- **4.7 Assignment**. Neither this Agreement, nor any rights are assignable or transferable (as security for advances or otherwise). Vendor will not assign or subcontract any portion of Services encompassed by an Agreement.

TTU will not recognize any assignment or subcontract made without TTU's prior written approval, and any such assignment by Vendor will be wholly void and ineffective for all purposes unless made in conformity with this section.

- **4.8 Registration of Sex Offenders**. All sex offenders required to register with local law enforcement authorities under Texas Code of Criminal Procedure §62.153 who intend to work on any campus of TTU for a consecutive period exceeding fourteen (14) days or for an aggregate period exceeding thirty (30) days in a calendar year are required to register with the TTU Police Department ("TTPD") within seven (7) days of beginning work on any campus of TTU. In addition, such sex offenders are required to notify TTPD within seven (7) days of terminating work on any campus. Therefore, if Vendor's employees and subcontractors will be performing Services on any of TTU's campuses, it is Vendor's responsibility to comply with this requirement. - 4.9 INDEMNIFICATION. CONTRACTOR WILL INDEMNIFY AND HOLD HARMLESS TTU, INCLUDING THE TEXAS TECH UNIVERSITY SYSTEM, ITS BOARD OF REGENTS, OFFICERS, AGENTS, EMPLOYEES, AND PERSONNEL, AGAINST ANY AND ALL LIABILITY, CLAIMS, SUITS, LOSSES, COSTS, AND LEGAL FEES CAUSED BY, ARISING OUT OF, OR RESULTING FROM ANY ACT OR OMISSION BY VENDOR, ITS EMPLOYEES, OR ANY OF ITS SUBCONTRACTORS IN THE PERFORMANCE OR FAILURE TO PERFORM UNDER THIS AGREEMENT. THIS INDEMNIFICATION EXTENDS TO AND INCLUDES INDEMNIFICATION FOR DAMAGES THAT RESULT FROM A BREACH OF THIS AGREEMENT BY VENDOR, THE NEGLIGENT ACTS OR **OMISSION OF VENDOR 'S SUBCONTRACTORS OR EMPLOYEES, AND CLAIMS RELATED TO INFRINGEMENT OF THIRD-PARTY INTELLECTUAL PROPERTY. THIS** INDEMNIFICATION ADDITIONALLY EXTENDS TO AND INCLUDES INDEMNIFICATION FOR DAMAGES OR LOSSES OF ANY KIND THAT OCCUR OR ARISE FROM THE SERVING OF ALCOHOL AND/OR THE CONSUMPTION OF ALCOHOL, INCLUDING BUT NOT LIMITED TO ALL CAUSES OF ACTION, CLAIMS, OR LAWSUITS FOR DAMAGES FOR PROPERTY DAMAGE, PERSONAL INJURY, OR DEATH. THE INDEMNIFICATION OBLIGATIONS SET FORTH IN THIS AGREEMENT WILL SURVIVE ANY TERMINATION OR EXPIRATION OF THIS AGREEMENT.
- **4.10 Governing Law.** This Agreement and all of the rights and obligations of the Parties and all of the terms and conditions under this Agreement will be construed, interpreted, and applied in accordance with, governed by and enforced under the laws of the State of Texas. Lubbock County, Texas, will be the sole proper place of venue for any proceeding concerning a dispute arising out of this Agreement.
- **4.11 Dispute Resolution**. The dispute resolution process provided for in Texas Government Code Chapter 2260 and the related rules adopted by the Texas Attorney General pursuant to Chapter 2260 will be used by TTU and Vendor to attempt to resolve any claim for breach of contract made by Vendor that cannot be resolved in the ordinary course of business. The chief procurement officer of TTU will examine Vendor's claim and any counterclaim and negotiate with Vendor in an effort to resolve such claims. The Parties specifically agree that (i) neither the execution of the Contract by TTU nor any other conduct, action, or inaction of any representative of TTU relating to the Contract constitutes or is intended to constitute a waiver of TTU's or the state's sovereign immunity to suit; and (ii) TTU has not waived its right to seek redress in the courts.

4.12 Notices. Notices will be effective under this Agreement when they are reduced to writing and delivered by next-day delivery service, with proof of delivery, or mailed certified or registered mail, return receipt requested, or by email to the appropriate Party at the address stated below. Notice will be deemed given on the date delivered or the date of attempted delivery if service is refused.

4.13 Applicable Laws & Regulations. Vendor agrees that it will comply with all federal, state, or local laws or regulations applicable to Vendor's performance under the Contract and agrees to obtain and maintain all permits, licenses, and other approvals required in connection with the operations contemplated under the Contract. Vendor also agrees that pursuant to Texas Education Code §51.9335(h), in any Contract for the acquisition of goods or services to which TTU is a party, any provision required by applicable law to be included in the A is considered to be part of the Contract whether or not the provision appears on the face of the Contract or if the Contract contains any provision to the contrary.




