For the next item of business, Akers presented the summary of course proposals. The only course proposal was an informational item to remove the restrictions from HIST 3327. Akers then presented the summary of program proposals, beginning with the voting items. The first voting item was for the International Business undergraduate certificate, which was proposed to have a change of title and curriculum. Items 2-5 were proposals to move several undergraduate minors in the previous dean's office department in the College of Health and Human Sciences to the new Interdisciplinary Human Sciences department. Akers called for a motion to approve items 1-5. Durband moved, Cox seconded, and the programs were approved. The remaining two program proposals were curricular changes.

For the next item of business, Tapp gave an update on the access to course materials in RaiderCanvas. RaiderCanvas will fully replace Blackboard as of the start of fall 2025. TTU has hired K16 Solutions, a third-party vendor, to migrate courses into RaiderCanvas. Tapp answered several questions about the migration.

Next, Akers mentioned that at the February meeting, we will look at Academic Council and its membership, responsibilities, and voting structure.

Akers then called for items of other business. Hearing none, Akers urged associate deans to help Bobbie Brown get missing instructors of record listed on appropriate courses by the deadline.

Hearing no items of other business or announcements, Akers called for a motion to adjourn. Cox moved, and Akers adjourned the meeting.
