

## **SACSCOC Program Closure Teach Out Questions**

- 2. Provide the closure date, defined by SACSCOC, as the date when students are no longer admitted.

Example Response: Students were no longer admitted into the MA Counseling Psychology degree program on Monday, August 25, 2022.

- 3. Provide a communication plan to inform all affected parties of the closure to include
  - a. how each of the following will be informed for the closure:
    - i. currently enrolled students,
    - ii. students with lapsed enrollment (i.e., not currently enrolled but recently enrolled), and
    - iii. prospective students.
  - b. how faculty and staff will be informed, viz., admissions and recruiting / marketing staffs; and
  - c. how community or industry partners will be informed. If not applicable, provide an affirmative statement to that effect.

Example Response: Since there are no currently enrolled students, students with lapsed enrollment, or prospective students, there is no need for a communication plan. The degree program is no longer advertised on the TTU website. Faculty and staff will be informed of the formal SACSCOC program closure at a Spring 2025 Department of Psychological Sciences faculty meeting. Notification of the degree program's closure will be announced at a forthcoming Academic Council meeting. Academic Council serves as TTU's primary academic decision-making body. No community or industry partners need to be informed.
