Facilitate and further College-level diversity/equity/inclusivity/access mission within all units and curriculum, create and sustain Rooney Rule for all recruitment and hiring, and collaborate with faculty on new initiatives in mentoring, personnel and tenure/promotion/merit manual revision, and Civic Discourse initiatives to support those efforts. Advocate for faculty, staff, and students within the community and state, including winning funding for two new academic buildings within the College, growing pre-College dual credit programs, articulation agreements, Honors College curriculum development, originating Living Learning Communities for the College, and building out academic pathways for College advising staffs. Oversee College efforts in accreditation (and Department-level accreditation), faculty workload and collective bargaining issues, Orientation programs, recruitment programs, and new degrees. Recognize and support the contributions of staff, improve working conditions for all College employees, focus on leadership development for staff, faculty, and chairs. Seek opportunities to further faculty development, creativity, and scholarship; increase participation for students in experiential and inquiry-based research across the disciplines. recognize and support the contributions of staff, and raise the visibility of the College. Work closely with faculty, staff, alumni, community members, and university leadership to advance the College's tradition of academic excellence, teaching, and civic engagement, especially on ethical issues resulting from the reciprocal relationship between the University and surrounding region.

**Associate Dean of Undergraduate Programs, University College (September 2016-July 2019)**  
*University of Texas at San Antonio*

Reporting to the Dean of University College, tasked with developing and implementing a range of College and University policies, practices, curriculum, and activities designed to engage all UTSA students with high-impact, engaged, experiential learning. Promote collaboration between administration and Faculty Senate for programs that are deemed central to undergraduate student success, including pre-college preparation, transition to college, academic advising, the National Student Exchange program, College academic programs (ROTC, the Multidisciplinary Studies BA, the Writing Program, the Office of Health Professions, the Institute for Law and Public Affairs, the Center for Civic Engagement), success coaching, academic learning communities, university tutoring, academic pathways, and undecided and undeclared students. Provide oversight for College and University efforts in accreditation, articulation agreements, faculty workload, Orientation programs, recruitment programs, and the development of a Service Learning undergraduate certificate. Support Dean and Program Directors with the transition to Hybrid Incentivized Budget Model; assist Program Directors with faculty recruitment, training, and course implementation; develop Institutional Research/Executive Advising Key Performance Indicators for majors.

**Interim Associate Dean, Honors College (August 2015-August 2016)**

Reporting to the Interim Dean of the Honors College, tasked with managing and evaluating all staff, advisors, and faculty for College; direct budgets for NTT faculty and College's scholarship compliance. Participate in research (NCUR) and graduate school events (such as Carnegie Mellon's PPIA recruiting events with students).
