## Faculty Senate Tenure and Privilege Committee

## <u>Report to the Faculty Senate</u>

December 3, 1985

The Tenure and Privilege Committee considered, at the request of the Fresident of the Faculty Senate, the letter from Benjamin H. New omb concerning the decision of the Office of Academic Publications not to publish the proceedings of the symposium "War and Peace: Perspectives in the Nuclear Age." Was that decision made for reasons which violate academic freedom?

The majority of the Committee found, in the material available to it, no indication of a violation of academic freedom. There is no impediment to publication of the symposium proceedings elsewhere; only the decision of Texas Tech Press not to publish is involved. In the view of the majority of this committee, the free exercise of editorial judgment by one charged with that responsibility is parallel to the exercise of academic freedom by faculty members and should be preserved.

It is not within the charge of this Committee to consider the wisdom of the Tech Press decision or decision-making procedures. The possibility exists that there are questionable management practices by Texas Tech Press with respect to how decisions regarding publications are made. Should the Senate wish, it might assign the study of that issue to another committee.

One member of the Committee dissented from the decision of the majority on the grounds that the Committee is unable at this point to tell for certain whether a violation of academic freedom has occurred. However, the fact that the Executive Director of the Texas Tech Press/Academic Publications overrode the substantive editors, because he found what had been written the Conference participants and approved by the substantive editors to be "propagandistic," gives that decision the appearance of having been made for an improper reason. That decision for that reason might well be a violation of the academic freedom of the editors, of the authors, or indeed of the academic community of Texas Tech University.
