5-17	required information must be provided in connection with the
5-18	information displayed under Subsection (c)(1) and must include a
5-19	link to the primary federal student financial aid Internet website
5-20	intended to assist persons applying for student financial aid.
5-21	(f) The board shall provide on the board's Internet website
5-22	a program or similar tool that will compute for a person accessing
5-23	the website the estimated net cost of attendance for a full-time
5-24	entering first-year student attending an institution of higher
5-25	education. The board shall require each institution to provide the
5-26	board with the information the board requires to administer this
5-27	subsection.
6- 1	(g) The board shall prescribe the initial standards and
6-2	requirements under this section not later than January 1, 2010.
6-3	Institutions of higher education shall comply with the standards
6- 4	and requirements not later than April 1, 2010. This subsection
6- 5	expires January 1, 2011.
