Guest Speakers

Dr. Lawrence Schovanec-President

Dr. Schovanec explained his decision to fund the Staff Emergency Fund at \$7,500 a year. He also addressed issues surrounding Senate Bill 17, noting that time will tell how the bill will or may impact enrollment. He mentioned that while our university-wide commitment to inclusion will not change, our methods have and will have to change.

Genevieve Durham DeCesaro-Vice Provost for Faculty Success

Genevieve Durham DeCesaro spoke about her time spent seeking the input from a wide array of faculty and staff about issues and questions they have surrounding SB 17. If staff have questions, Genevieve is happy to address and help as needed.

Jeremy Haggard shared about community service opportunities for students, to which Dr. Schovanec expressed gratitude and shared information about Raider Rojos Alumni Network.

Feroza Haq inquired about resources for the spouse/partners of students. Dr. Schovanec highlighted some resources, such as the Food Pantry and the Employee Assistance Program.

Rachel Bloodworth asked about using specific inclusive statements in recruitment materials, and Genevieve Durham DeCesaro recommended that it is best to reach out to her directly with specific questions like this.

Rodney Lackey shared that the university Title IX training mentions inclusivity in a way that seems at odds with SB 17, and asked for Dr. Schovanec's input.

Theresa Madrid asked about being denied permission for her department to buy food for their cultural event. Dr. Schovanec said that there is an application process for similar instances, as the university needs documentation for these events. Genevieve Durham DeCesaro mentioned that there is a possibility of funding student organizations, which could in-turn fund an event.

Lindsey Crowley-Scott asked what we should do if we encounter a faculty or staff memember who is wanting to leave due to SB17. DeCesaro encouraged employees to ask how we can help when encountering these individual issues.

Beth Watson asked about departmental reporting to external agencies requesting demographic information about students for accreditation purposes. DeCesaro said it is permissible to report that student information as it pertains to accreditation.

Carol Bonner asked if Staff Senate could use budget funds to create a "you belong" sticker. DeCesaro answered in the affirmative.

Rosa Testini has found it hard to see how faculty are engaging in new hire processes for faculty in an inclusive way. DeCesaro said that we continue to hire according to our affirmative action plan.

Genevieve Durham DeCesaro encouraged staff to check in on one another, ask if they are okay, and support one another.
