

RAIDERGATE POLICIES 2019

NO GLASS CONTAINERS AT RAIDERGATE FOR BEVERAGES, FOOD, or CONDIMENTS!

RaiderGate passes are available to Texas Tech University students only.

RaiderGate Dates:

Montana State vs. TTU = Aug. 31

UTEP vs. TTU = Sept. 7

Oklahoma State vs. TTU = Oct. 5

Iowa State vs. TTU = Oct. 19 (Homecoming)

TCU vs. TTU = Nov. 16

Kansas State vs. TTU = Nov. 23

Individual students = 2 pass max Student Organizations = 6 pass max

(The student who obtains the RaiderGate pass(es) must be present in the vehicle on the day of the event.)

RaiderGate will be held at the R-1 Parking Lot (15th & Detroit). RaiderGate will **open four (4) hours prior to kickoff**. Pass holders must check in at the entry station located at 15th & Detroit (TTU campus). Entry gates will **close 30 minutes prior to kickoff** and no vehicles will be allowed to enter at that time. RaiderGate activities will end two (2) hours **after** kickoff, and the lot will be cleared by RaiderGate staff and security. **Vehicles must remain in the lot until the end of the game, or four (4) hours after kickoff, whichever comes first.**

To ensure that RaiderGate provides a safe and festive atmosphere for Texas Tech University students to prepare for Red Raider football, students are expected to abide by the following guidelines:

- **NO GLASS containers for food, condiments or drinks will be allowed.**
- All beverages must be in a RaiderGate cup – no exceptions. All cups must be emptied before leaving the RaiderGate lot. RaiderGate cups can be obtained at the entry station as you enter the RaiderGate lot.
- No common source alcohol containers or activities that promote the rapid consumption of alcohol will be allowed at RaiderGate, including but not limited to kegs, funnels, shots, drinking games, or other drinking paraphernalia, etc.
- **No vehicles are allowed in the lot to drop off or pick up tailgaters or tailgate supplies.**
- No oversized vehicles or cookers will be permitted at RaiderGate including but not limited to RVs, campers and semi-trucks. All vehicles & cookers must fit into the parking space for which the pass is assigned.
- All vehicles entering the lot must be street legal. The use of four-wheelers, golf carts, gators, and scooters are prohibited. Skateboards and bikes are not to be used in the RaiderGate lot.
- Vehicles without RaiderGate passes will be towed at the owner's expense.
- Respect the campus buildings, grounds, and landscape. Nothing can be attached to university property, including trees, buildings, handrails, lampposts, etc.
- No hammocks, slack lines, or tight ropes may be used at RaiderGate.
- Place all trash and recycling in the proper bins located throughout the tailgate area and campus, for your convenience. Separate bins are available for coal disposal.
- Tents and similar coverings must be securely weighted or anchored. Tents larger than 10' x 10' are not allowed at RaiderGate.
- No pets allowed at RaiderGate.
- Texas Tech University, Student Union & Activities, and Texas Tech Athletics are not responsible or liable for accidents, damage, loss, or theft of personal property left in the tailgating area. It is the responsibility of each RaiderGate pass holder to secure tailgate supplies prior to entering the stadium.

RaiderGate is a privilege to Texas Tech University students. The close configuration of RaiderGate and the RaiderGate lot requires that all students be good neighbors and conduct themselves in a manner that is courteous to other tailgaters.

All RaiderGate participants are expected to abide by the Texas Tech University Code of Student Conduct and all applicable laws.

Texas Tech University reserves the right to suspend or terminate any individual's or group's privileges to participate in RaiderGate at any time for violations of these guidelines. Inappropriate behavior or conduct that is inconsistent with RaiderGate and University policies will result in the permanent loss of all tailgating privileges. Student violations of this policy are subject to disciplinary action by the appropriate university officials.
